TOWN OF ARLINGTON BOARD OF SELECTMEN

Meeting Minutes Monday, November 9, 2015 7:15 PM

Present: Mr. Greeley, Chair, Mrs. Mahon, Vice Chair, Mr. Dunn, Mr. Curro Jr., and Mr. Byrne Also Present: Mr. Chapdelaine, Mr. Heim and Mrs. Sullivan

Chairman Greeley opened the meeting thanking all veterans for their service to the country. He then invited all veterans and residents to attend the annual Veteran's Day Parade (from Walgreen's to Monument Park) and Ceremony to be held at Monument Park immediately following the parade.

1. Request: Vote to Approve the Board Sale of \$9,232,000 General Obligation Bond Anticipation Noted dated November 13, 2015; \$4,362,000 General Obligation Municipal Purpose Loan of 2015 (Bonds) – Series-A; and \$3,225,000 General Obligation Refunding Bonds – Series-B.

Stephan J. Gilligan, Town Treasurer

Mr. Dunn moved approval of the following vote:

<u>Voted</u>: That in order to reduce interest costs, the Treasurer is authorized to issue refunding bonds, at one time or from time to time, pursuant to Chapter 44, Section 21A of the General Laws, or pursuant to any other enabling authority, to refund all of the Town's (i) \$5,171,000 General Obligation Municipal Purpose Loan of 2005 Bonds dated September 15, 2005 and maturing in the years 2016 through 2020, inclusive, in the aggregate principal amount of \$1,000,000 (the "Refunded 2005 Bonds"), and (ii) \$8,100,000 General Obligation Municipal Purpose Loan of 2006 Bonds dated July 15, 2006 and maturing in the years 2017 through 2025, inclusive, in the aggregate principal amount of \$2,350,000 (the "Refunded 2006 Bonds" and collectively with the Refunded 2005 Bonds, the "Refunded Bonds"); and that the proceeds of any refunding bonds issued pursuant to this vote shall be used to pay the principal, redemption premium, if any, and interest on the Refunded Bonds, and costs of issuance of the refunding bonds.

<u>Further Voted</u>: that the sale of the \$4,362,000 General Obligation Municipal Purpose Loan of 2015 Bonds, Series A, of the Town dated November 13, 2015 (the "Series A Bonds"), to Fidelity Capital Markets, a division of National Financial Services LLC ("Fidelity"), at the price of \$4,905,165.89 and accrued interest, if any, is hereby approved and confirmed. The Series A Bonds shall be payable on November 1 of the years and in the principal amounts and bear interest at the respective rates, as follows:

<u>Further Voted</u>: that the sale of the \$3,225,000 General Obligation Refunding Bonds, Series B, of the Town dated November 13, 2015 (the "Series B Bonds" and together with the Series A Bonds, the "Bonds"), to Fidelity at the price of \$3,466,721.14 and accrued interest, if any, is hereby approved and confirmed. The Series B Bonds shall be payable on July 15 of the years and in the principal amounts and bear interest at the respective rates, as follows:

<u>Further Voted</u>: to approve the sale of \$9,232,000 2.00 percent General Obligation Bond Anticipation Notes of the Town dated November 13, 2015, and payable November 10, 2016 (the "Notes" and together with the Bonds, the "Obligations"), to Eastern Bank at par and accrued interest, if any, plus a premium of \$146,709.94.

<u>Further Voted</u>: that in connection with the marketing and sale of the Obligations, the preparation and distribution of a Notice of Sale and Preliminary Official Statement, one for the Bonds and one for the Notes, each dated October 27, 2015, and a final Official Statement, one for the Bonds and one for the Notes, each dated November 5, 2015 (the "Official Statement"), each in such form as may be approved by the Town Treasurer, be and hereby are ratified, confirmed, approved and adopted.

<u>Further Voted</u>: that the Series A Bonds shall be subject to redemption, at the option of the Town, upon such terms and conditions as are set forth in the Official Statement.

<u>Further Voted</u>: to authorize the execution and delivery of a Refunding Escrow Agreement to be dated November 13, 2015, between the Town and U.S. Bank National Association, as Escrow Agent and Paying Agent.

<u>Further Voted</u>: that the Town Treasurer and the Board of Selectmen be, and hereby are, authorized to execute and deliver continuing and significant events disclosure undertakings in compliance with SEC Rule 15c2-12 in such forms as may be approved by bond counsel to the Town, which undertakings shall be incorporated by reference in the

Obligations, as applicable, for the benefit of the holders of the Obligations from time to time

<u>Further Voted</u>: that we authorize and direct the Treasurer to review and update the Town's post-issuance federal tax compliance procedures with such changes, if any, as the Treasurer and bond counsel to the Town deem sufficient in order to monitor and maintain the tax-exempt status of the Obligations.

<u>Further Voted</u>: that each member of the Board of Selectmen, the Town Clerk and the Town Treasurer be and hereby are, authorized to take any and all such actions, and execute and deliver such certificates, receipts or other documents as may be determined by them, or any of them, to be necessary or convenient to carry into effect the provisions of the foregoing votes.

Mr. Viscay presented the quarterly financial report ending 9/30/15 including:

- An executive summary of revenues, expenses, fund balances of the major funds of the Town; and

He explained that the reports can be customized to suit the Board and its interests.

<u>CITIZENS OPEN FORUM – SIGN IN PRIOR TO BEGINNING OF OPEN FORUM</u>

This matter was presented for consideration of the Board.

Mr. Gordon Jamieson presented the recycling update announcing that this Saturday was the community recycle day at the Public Works parking lot from 9-1. This is Arlington's 10th year holding this community recycle day—he commended the residents for their great recycle efforts.

11. For Approval: Handicap Parking Sign @ 12 Lockeland Avenue Linda Papazian

Mr. Byrne moved to table until the applicant is present. SO VOTED (5-0)

12. For Approval: Letter to Governor – Green Line Extension Howard Muise, Chair, TAC

Mr. Muise explained that the Green Line Extension Project is under extreme financial pressure and the original budget of \$1.9 billion is now projected at \$2.9 billion. TAC is monitoring the project status and does support the extension project of the Green Line. TAC is requesting the Board to send a letter of support for the project to Governor Baker. Mr. Curro moved approval to have the Chair sign the letter.

13. Discussion: Traffic Signals at Intersection of Mass Ave/Mill/Jason

Transportation Advisory Committee

Adam W. Chapdelaine, Town Manager

Michael Rademacher, Director of Public Works

Mr. Greeley introduced everyone and stated that TAC would speak first with the Director of Public Works next. The Selectmen will have time for questions and answers and then the public will have time to make comments.

Mr. Maxtuitis, TAC Co-Chair, explained the study and recommendations set forth to the Selectmen in 2013 that were voted approved.

Mr. Rademacher explained the installation of the new traffic signals in October of 2015. He went through the problems of the installation and the current issues being dealt with on the signals.

Ms. Maurer of 15 Jason Street, Ms. Carney of 98 Richfield Road, and Ms. Madden of 71 Cutter Hill Road presented a petition of nearly 700 citizens requesting to have the light signals restored to exclusive pedestrian crossing at Mass. Ave, Mill St., and Jason St. They cited the following reasons: 1) the changes approved by the Selectmen on May 9, 2013 do not match the actual changes that have been implemented; 2) concurrent pedestrian crossing was implemented despite failing to meet the criteria recommended by the Boston Metropolitan Regional Planning Organization; and 3) pedestrians now fear for their lives at this intersection –traffic has not improved, pedestrian-vehicle conflict has increased, and local businesses are already worried about losing customers.

Ms. McCauley of 1184 Massachusetts Avenue commented she has a profoundly deaf family member and they do not feel safe crossing since the traffic signal changes.

Ms. Wirkkala, owner of Laura's Sewing School at 785 Massachusetts Avenue stated she hears honking and sees conflicts during the day and that there was an accident 2 days ago because of the changes.

Mr. Erlich of 741A Massachusetts Avenue commented his family is in danger with the changes. Cars speed down Jason Street at night going 30 to 35 mph trying to get through the green light and could easily hit a pedestrian crossing the street. He stressed the urgency to make changes soon before there is a death.

Mr. Radochia of 45 Columbia Road stated that the signal cycle takes 3 minutes 15 seconds to loop. Currently the pedestrian lights go even though there is no one crossing. He also suggests more street lighting is needed for the safety of the pedestrians.

Mr. Hossam Ali of 68 Bacon Street supports pedestrian safety and better street lighting.

Ms. Hermann for Tom Brown of 30 Mill Street reported the audible sounds for the hearing impaired cannot be heard and add to the confusion since the changes.

Mr. Fuller of 7 Kilsythe Road proposed that the traffic signals be changed back because with the Arlington Center improvements of installing parking meters more people may be walking Massachusetts Avenue from unmetered parking areas creating an increase in foot traffic.

Ms. Worden of 27 Jason Street commented that the recent changes are a disaster and should have the prior traffic signals reinstated immediately. She pointed out that the Selectmen are the only ones who can change these traffic rules.

Ms. Crohan of 170 Mystic Street explained the difficulty in crossing for sighted and visually impaired pedestrians. The audible sounds are out of sync with the light. The current change is a safety issue for all.

Mr. Cassidy of 15 Jason Street suggested that the Jason St. Island lines tighter in towards the island

Mr. Eberle of 37 Bartlett Avenue stated his support for pedestrian safety and quick action on changing the traffic signals back to what they were.

Mr. Klein of 54 Newport Street commented there was no notice of the change and it was very confusing for vehicles, cyclists, and pedestrians.

Mr. Greeley thanked everyone for attending and the great citizen involvement. He thanked TAC for their excellent work in all of projects that they do for the Town.

There was discussion by the Selectmen, TAC and Public Works Director, Michael Rademacher on why exclusive pedestrian signals and split signal phasing (Mill St. and Jason St.) cannot both occur together as an alternative

Mrs. Mahon moved to restore the exclusive pedestrian crossing by adopting the Build 1 alternative option recommended by TAC and maintain existing markings.

SO VOTED (5-0)

At 9:40 pm the meeting moved back to the Selectmen's Chambers for the remainder of the meeting.

Mr. Chapdelaine explained the task force would meet up to twice a month to examine the issue, review alternatives, solicit public input, and recommend solutions.

Mr. Byrne made a motion that Mrs. Mahon and Mr. Curro be the Selectmen members appointed to the School Enrollment Task Force (SETF).
