1. For Approval: 'Cause + Event Arlington 2016' 15K Race, May 22, 2016 Julie Vakoc and Robin Olinsky

Ms. Olinsky stated that the Cause & Event Foundation vision and mission is to raise as much money as possible for as many causes possible in as many communities possible, and also to connect the philanthropic giving of athletes who participate in our events to the causes they hold dear. Last year they raised more than \$10,000 for 89 non-profits, many of which were local to Arlington. The event encourages entire families to participate in both the Kids Run and 5K to promote health and wellness initiatives in the community.

 Discussion and Adoption: Cable Television Ascertainment Report and Process John F. Maher, Esq.
 Cable Advisory Committee Chair

John Maher. Chair, Cable Advisory Committee stated that with the assistance of the Town Manager and Town Counsel, the Cable Advisory Committee has drafted an Ascertainment Report as required under State and Federal Law. The report has been broken down into various categories, each representing a stage of the Ascertainment Process. They include a survey, a public hearing held by the members of the Board on April 15, 2015, and interviews with several stakeholders, including department heads and representatives of the Arlington Community Media, Inc.

The Board moved that pursuant to the provisions of the Cable Communications Policy Act of 1984 and Chapter 47 of the Cable Services Code, Section 546, (a), the Board of Selectmen as the Town of Arlington Cable Television Issuing and Licensing Authority adopts the draft Ascertainment Report dated November 16, 2015 as prepared by the Town Cable Advisory Committee.

6. For Approval: Capitol Square Banners

Jan Whitted, Owner, Artbeat for the Capitol Square Business Association
Jan Whitted, owner of Artbeat, requested that the Capital Square businesses would like to install banners to their business district and give a sense of who they are. Their request is to use 14 of the 38 new lampposts for signage that specifically names Capitol Square as a place.

Mr. Dunn moved approval for one year with some flexibility if the Town Manager or Board

of Selectmen feel there are other Town functions and events such as "Feast of The East" going on that needs publicity.

7. For Approval: Request Letter for Heavy Commercial Vehicle Exclusion on Jason Street Steven M. Byrne, Selectmen

The Board voted to approve a letter to Mass DOT recommending a heavy vehicle restriction on Jason Street following complaints from concerned neighbors. Mr. Byrne stated he feels the issues need to be addressed after several meetings with neighbors and he worked with the Traffic Advisory Committee to draft the recommendation letter being sent to Mass DOT. Although data from TAC doesn't show a high frequency of heavy commercial vehicles, Mr. Byrne feels any

amount of trucks was too much.

Mr. Dunn stated he was voting against the recommendation because he is concerned about neighbors or other streets now making a similar request.

Mr. Byrne stated he would expect the Board to evaluate these requests on a case by case basis and that a blanket policy wouldn't suffice.

Mr. Byrne moved approval.

# 8. For Approval: CDBG Reallocation Request Adam W. Chapdelaine, Town Manager

Town Manager Adam Chapdelaine requested that the Board vote to reallocate CDBG funding that had previously been allocated to a zoning recodification effort. The CDBG Budget allocated \$50,000 for "tools and services to prepare and recommend a revised zoning bylaw to land use and redevelopment consistent with the Comprehensive Master Plan". Eight thousand (\$8.000) will be used for a Right Side Parking Study. The data from this study will help determine if we can reduce the parking requirement in the zoning bylaw for multi-family residential and mixed use development in commercial corridors and multi-family residential zones. Of the remaining funding, \$25,000 will be put towards a design study for the Mass. Avenue Corridor Phase 2 from Pond Lane to Mill Street. Additional funds from CDBG will be used to conduct outreach and get public input on priorities for the Center, particularly focused on Broadway Plaza design and sidewalk surfaces, as well as preliminary roadway design.

Mr. Dunn moved approval.

Town Manager Chapdelaine requested the Board's approval of the Draft Request for Proposals (RFP) regarding the Town owned property at 1207 Mass. Avenue (formerly the DAV). The draft aims at meeting the Board's goal of providing a short term lease opportunity for a cooperative/collative effort in tenanting the space. It also maintains the Board's goal of moving to consider sale of the building during FY2017 in order to have funds available for Town capital investments.

The RFP, drafted by Town Counsel Heim lists February 1, 2016 as the desired start date for a twelve (12) month lease of building.

### **NEW BUSINESS**

Town Counsel stated the Board received supplemental filings from SEB regarding the Mugar Property 40B application and that the developer's application is likely considered complete by MassHousing. He and special counsel will examine the supplemental filing in further depth, but noted the two robust comment letters the Board has already provided and that the Town is not aware of any deadline for a decision on site approval.

Mr. Chapdelaine stated on Saturday, Nov. 21st, the Board of Selectmen, Town Manager and Mass DOT representatives celebrated the completion of the main portions of roadwork on Massachusetts Avenue in East Arlington. The ribbon cutting was held at the corner of Grafton Street and Massachusetts Avenue and was well attended.

Mr. Chapdelaine stated he will introduce the newly hired Deputy Town Manager, Sandy Pooler, to the Board at their meeting on Monday, December 21st.

Mrs. Mahon informed the Board that Arlington High School and Arlington Catholic High School would be playing Thanksgiving Day at 10:00 a.m. and hoped all would attend. It is always a good time and she looks forward to seeing everyone at the game.

Mr. Dunn stated he was very happy to attend the ribbon cutting on Saturday for the completion of Mass. Avenue and wanted to thank TAC and Scott Smith for all their work with the Mass. Avenue Corridor.

Also he has been very busy attending several meetings regarding the Minuteman High School Construction.

This past Friday, he attended the Long Range Planning Committee meeting and they discussed a future Override and Debt Exclusion for the new Arlington High School, Minuteman High School, elementary school enrollment increases, and also forthcoming budgets.

Mr. Greeley stated, to his knowledge, it was the first time all five members of the Board attended the Veterans Memorial Day Parade. Due to the inclement weather, the speeches were held insideour newly renovated Fire Station. He stated that Jeffrey Chunglo, Director of Veterans Services, did an outstanding job.
