Mr. Feeney stated that on March 4 the Board had a preliminary hearing and identified a number of conditions that needed to be met prior to tonight's continued hearing. To that respect, there was an inspection of this establishment conducted by the Fire Department and the Inspectional Services Department on March 6, at this point a number of conditions were identified for correction, those conditions were provided to the Board prior to the meeting and included in the reference. Mr. Feeney continued noting that the separately a hearing was held with staff at the Board of Health on Thursday, March 7 by Pat Martin, Health Compliance Officer. There were a number of conditions that will need to be met over time including working with a food safety consultant starting on or before April 5th. As of today, no action has been taken with respect to hiring a food safety consultant to conduct comprehensive inspections and trainings. With respect to items that were identified during the March 6th field inspection conducted by the Inspectional Services Department and the Fire Department we scheduled a follow-up inspection in advance of this Select Board meeting to be taken place today at 10a.m. and the applicant was not present.

Mr. DeCoursey moved to deny the application for a Common Victualler License located at 1323 Massachusetts Avenue.

Mr. Cunningham noted that the legal department will work with the Town Manager's Office, Inspectional Services and all other departments to ensure that the business does not open without a license.

13. Arlington Community Electricity Contract Renewal

Talia Fox, Sustainability Manager

Talia Fox appeared before the Board and gave a brief presentation regarding the upcoming contract renewal for the Arlington Community Electricity Program. Ms. Fox

noted that the goal is for the Select Board to provide the Town Manager with guidance regarding a target percentage range or the default product to inform the supplier bidding process that will occur in approximately two weeks. Ms. Fox stated that electricity customers in MA are required to pay for electricity distribution for the utility, but we can choose to purchase electricity supply from competitive suppliers. Arlington Community Electricity or ACE was launched in 2017. It is a town vetted municipal aggregation program, enabled by state law that allows the town to purchase competitive electricity supply in bulk on behalf of the residents. Ms. Fox stated that there are many goals and benefits of this program. The town is currently in a two-year contract with NextEra services, which began in November of 2022 and completes in November of 2024 and has four various products for extra renewable energy. Ms. Fox highlighted the program astonishments as of December 2023 stating that 15,221 accounts enrolled and of that 1,230 accounts are enrolled in 100% product. Ms. Fox stated that the Town has the opportunity, this contract to select a default rate of renewable energy that is higher than the current 30% default rate and addressed the considerations and cost increases for residents. Ms. Fox explained that an additional consideration for the contract renewal pertains to the ACE program product options. Ms. Fox briefly summarized the next steps stating that tonight the goal is for the Select Board to provide guidance to the town manager on the approach for the procurement. That procurement will take place in early April after which point the town will finalize the contract with the lowest bidding supplier. This fall the town will begin marketing the new contract rates and products to prepare for the transition to the new contract.

The Board thanked Ms. Fox for her presentation. Mr. Feeney noted that he appreciated the Board setting guidelines or parameters to follow with respect to setting the floor for where we hope to see the default product. The Board had a lengthy discussion regarding the different rates and noted that it would be a three-year contract.

WARRANT ARTICLE HEARINGS

14. Articles for Review:

Article 6 Bylaw Amendment/Vacant Store Front Maintenance Registry

Katie Lucazi appeared before the Board and stated that this article was inserted by the Town Manager and the Director of Planning and Community Development with proposed amendments to Title V, Article 17 of the Town's Bylaws ("Article 17"), which governs the Vacant Storefront Maintenance Registry. The proposed amendments seek to clarify the intent of Article 17 enforcement against vacant ground-level Main Street storefronts with frontage along Massachusetts Avenue and/or Broadway. The amendments further seek to remove the public art waiver option as a result of its ineffectiveness and lack of upkeep. Instead, any waiver(s) permissible under Article 17, as amended, would not include the public art waiver option. Next, the Article 17 proposed amendments include a definition of 'financial hardship' for clarification purposes. Finally, the proposed amendments to Article 17 streamline defined terms within the Article itself and contemplate that legal dispositions of the buildings and/or properties subject to the Bylaw may exist beyond a sale or lease thereof. The specific proposed language changes are set forth below in the draft vote language, included if the Select Board is inclined to act favorably on this matter. The Board voted unanimously in support of this bylaw amendment. Mr. DeCoursey suggested the Board consider whether state urban renewal laws (M.G.L. ch. 121B) could bolster enforcement of this bylaw and serve as another solution for storefronts that have long been vacant. Mr. DeCoursey recommended that the word 'unoccupied' be omitted from the definition of Main Street Storefront for clarity. Mr. DeCoursey further clarified that an outdated proposed component of the amendment to duplicate vacant signage provisions from the Town's Zoning Bylaws would not be included in the bylaw amendment.

Mr. Hurd moved favorable action.

Article 8 Bylaw Amendment/Annual Town Meeting Start Date

Phil Goff appeared before the Board and stated that he is seeking to amend the Town's Bylaw regarding the start date or time of Annual Town Meeting. Mr. Goff explained that the purpose of this bylaw is to allow the Select Board with flexibility regarding the setting of the date of the commencement of the Annual Town Meeting. This article also seeks to change the start time from 8:00p.m. to 7:00p.m.

The following members of the public spoke regarding this warrant article:

Greg Christiana, Town Moderator

The Board was presented with survey results that the Town Moderator facilitated to better understand the preference of responding Town Meeting Members for Town Meeting start time. Mr. DeCoursey inquired into whether the survey indicated results for an amendment to the Town Meeting start time, as opposed to the start date. The Town Moderator confirmed the priority of the survey was to focus on the start time.

Mr. Hurd moved to table Article 8 after observing that articles 8,9 and 10 were similar in substance.

SO VOTED (5-0)

The Board engaged in a thorough discussion regarding the start time for the Annual Town Meeting. Individual Board members identified the potential positive and negative impacts of moving the start time of Town Meeting from 8:00 pm to 7:00 pm or 7:30 pm. The Board also considered the favorability of allowing Town Meeting to determine its own start time after the first night.

Mr. Hurd moved that the Select Board will “will report” on its recommendation regarding this warrant article at some future time, including the possibility of doing so during Town Meeting, after further input from the Town Meeting Procedures Committee, or if requested by an individual Select Board member. SO VOTED (5-0)

Article 9 Bylaw Amendment/Revised Town Meeting Start Time

Krista Kelleher proponent of this warrant article appeared before the Board and stated a number of reasons as to why the start time of Town Meeting should change. This Article differs from Article 8 because it does not seek to amend the Bylaw. Instead, it only seeks to alter the start time of Annual Town Meeting from 8:00 pm to 7:30 pm.

Mr. DeCoursey moved to table Article 8 after observing that Articles 8,9 and 10 were similar in substance. SO VOTED (5-0)

Ms. Kelleher offered to withdraw the amendment if duplicative to Article 8 and 10. Mr. Hurd moved no action. SO VOTED (5-0)

Article 10 Bylaw Amendment/Start Time for Annual Town Meeting

Greg Christiana, Town Moderator appeared before the Board on behalf of the Town Meeting Procedures Committee. This article is similar to Article 8 because it also seeks to provide the Select Board with discretion to set the start date for Annual Town Meeting for a day other than the fourth Monday in April, if deemed to “better suit the public convenience for reasons it shall determine including, but not limited to, conflicts with the observance of religious holidays.”

The Board recognizes that this amendment will assist this and future Select Boards by providing flexibility with the setting of the date for the first night of the Annual Town Meeting so that conflicts with dates of religious observance or other important events can be avoided.

Mrs. Mahon moved favorable action. SO VOTED (5-0)

Article 11 Bylaw Amendment/Fossil Fuel Free Bylaw Language Changes

Mr. DeCoursey recused himself from this hearing.

Ms. Fox appeared before the Board and note that this Article was inserted by the Director of Planning and Community Development and the Town Manager. This Article proposes

to update the definition of major renovations as set forth in the Town's Fossil Fuel-Free Bylaw. The Fossil Fuel-Free Bylaw was added by Arlington's Special Town Meeting in October 2023. Ms. Fox stated that the goal of the Bylaw was to update the Town's previously approved Clean Heat Bylaw, enabling the Town's participation in the Municipal Fossil Fuel-Free Building Demonstration Program. The Massachusetts Department of Energy Resources (DOER) formally accepted the Town into the Demonstration Program on February 21, 2024. Ms. Fox explained that through its passage of the Bylaw, a prerequisite for participating in the Demonstration Program, the Town will restrict the use of fossil fuel infrastructure in new building construction and major renovations, in furtherance of the Town's goal to reach net zero greenhouse gas emissions by 2050. Further, this Article seeks to update the definition of major renovations in the existing Bylaw. Ms. Fox explained that the change in the definition will impact a slightly increased number of projects based on a reduced threshold percentage of the work area considered as a part of the total conditioned floor area. It is noted that the proposed Bylaw amendment does not eliminate the available exemptions or the option to pursue a waiver in cases where compliance with the Bylaw renders a project financially infeasible or impractical to implement.

The Board noted that the amendment would not be effective until approved by the Office of Attorney General. The Board further noted the amendments align with state regulations.

Mr. Hurd moved favorable action.

2. Community Preservation Act Committee Presentation

Clarissa Rowe, Chair

Clarissa Rowe, Chair of the Community Preservation Act Committee, appeared before the Board and presented the projects in the budget for the CPAC Fiscal Year 2025 that will be voted on at Town Meeting. Ms. Rowe stated that the Community Preservation Act is funded by a 1.5% surcharge from the property taxes of the residents combined with matching funds from the State Community Preservation fund to fund projects in three areas: historic preservation, open space and recreation, and community (affordable) housing projects. Ms. Rowe pointed out that the CPAC publishes the complete applications for these projects, including budgets, timelines, and voluminous letters of support from the community to the Community Preservation Acts webpage. Ms. Rowe and her CPAC colleagues detailed projects for the Arlington Housing Authority, Somerville

Homeless Coalition, Cambridge Salvation Army, Digitizing and Preserving Arlington's Marriage Records, Robbins Memorial Garden Restoration Planting, Foot of the Rocks Battlefield Memorial, McClennan Detention Pond Survey, Minuteman Bikeway Redesign, Crosby Park Court and Park Renovation and Menotomy Rocks Park Play and Picnic Area.

9. Discussion & Approval: Fiscal Year 2025 Water/Sewer Rates

Mike Rademacher, Director of Public Works

Mr. Feeney stated that he is before the Board tonight for their annual request. Mr. Feeney noted this is to adjust the water and sewer rates as noted in the memo that was provided to the Board prior to the meeting. Mr. Feeney explained that the water rates will be going up 3.05% and sewer rates will be going up 3.13%. Mr. Feeney explained that the main driver of that is the amount of water that we expect to be consumed in the community for the given year. Mr. Feeney explained that although this is an estimate it is an estimate based on historical consumption.

WARRANT ARTICLE HEARINGS

10. Articles for Review:

Article 15 Bylaw Amendment/Prohibition of Fair-Trade Restrictions - Fur Products

Ms. Dray appeared before the Board to present her warrant article which prohibits the sale of new fur products. Ms. Dray noted that this type of prohibition on the sale of new fur products has already been enacted in six other municipalities in Massachusetts – Wellesley, Weston, Plymouth, Brookline, Cambridge and Lexington. Ms. Dray argued that similar bylaws in surrounding towns were needed to address the suffering endured by animals that are raised on fur farms, in cramped and unsanitary conditions, before they are slaughtered. Ms. Dray also argued that the wide array of alternatives for fashion and apparel makes the demand for fur products unnecessary and does not justify the cruel treatment and cruel killing of animals.

The Board thanked Ms. Dray for her presentation. Mr. Hurd inquired as to the exclusion of second-hand fur sales from the bylaw amendment. Ms. Dray responded that passage of the bylaw warranted its omission because second-hand fur has already been through economic circulation. The Board agreed with the proponent's desire to amend the penalty fee from \$100 to \$300 in Section 5. Mr. DeCoursey inquired about the status of state law restricting the sale of new fur products, observing that this amendment signals to the Legislature that a similar state law may be well timed. Further, the Board agreed with the proponent that favorable action on the amendment would not result in any adverse economic impact in the Town, because no retail stores currently sell new fur.

Article 16 Bylaw Amendment/Pet Sale Restrictions/Retail Pet Sales

Ms. Kepka and Ms. Kiesel appeared before the Board and stated that similar to the last warrant article this warrant article would place a ban on pet stores to not allow the sale of dogs, cats, mammals, birds, reptiles and amphibians. Ms. Kiesel explained that this would not apply to animal shelters or private breeders. It is noted that like the previous Warrant Article, because this type of bylaw has been passed in other towns, the topic has been the subject of review by the Attorney General's Municipal Law Unit. Ms. Kiesel further explained that US pet dealers annually import 225 million live animals on average, endangering wild species in their native ecosystems. Many of these animals suffer and die during capture and transport and live in cramped and inhumane conditions. Ms. Kiesel stated that there are currently no pet stores in Arlington that sell animals but placing a ban on the sale is timeliness. Mr. Helmuth noted that Cambridge City Councilor Marc McGovern's letter to the Board noted that a similar ban was enacted in their City and resulted in a smooth transition away from retail pet sales, even though only one store was selling pets at the time.

The Board thanked Ms. Kiesel and Ms. Kepka for the presentation. Mr. Hurd noted the necessity and practicality of amending the bylaw to further include a ban on selling pet fish. The Board discussed whether it was appropriate to add fish as a category in the amendment. After consideration, the Board agreed to add a new section banning the sale

of pet fish but noted that this exclusion would need an exemption for fish used for food consumption.

Article 17 Bylaw Amendment/Right to Pet Companionship

Mr. Schlichtman appeared before the Board accompanied by Kristine Dorchick. Mr. Schlichtman stated that this warrant article proposes to require that residential rental agreements, such as leases, and condominium associations permit residents to own a common household pet, or to have a common household pet present in a dwelling. Ms. Schlichtman noted that this amendment would be the first of its kind in the Commonwealth and was intended to address pet restrictions impeding the availability of housing. Mr. Schlichtman further noted that the amendment was intended to address large, commercial residential buildings, such as apartment complexes and condominiums, because he believes that the prohibitions on pets are typically not an issue in smaller residential properties, such as two- or three-family homes. Ms. Schlichtman stated that the amendment was intended to address the disparity in permitted pet ownership and 75% of tenants renting residential apartments currently have pets.

Mr. Helmuth asked Mr. Schlichtman to articulate what the bylaw would seek to prohibit. Mr. Schlichtman acknowledged that condominiums could be permitted under the bylaw to issue reasonable restrictions on pets. Mr. Helmuth inquired about how the bylaw would be enforced and asked the proponent to consider what language could be added to address the practice of enforcement. The Board also heard lengthy comments regarding the legality of the amendment. Mr. Cunningham stated that the proposed Bylaw amendment would be subject to certain applicable laws. It is likely that this Bylaw amendment conflicts with current state and federal because it is noted that tenants' rights related to animal ownership are ordinarily subject to anti-discrimination and/or disability statutes. The conflict exists because there is not an unqualified right to pet ownership in the housing contemplated by this Bylaw amendment. The Board noted the value of the process and emphasized the need for robust commentary in the Board's draft votes and comments to guide Town Meeting on this matter.

Article 18 Bylaw Amendment/Historic Building Demolition Delay

Ms. Robinson appeared before the Board and stated that this Article seeks to amend the current demolition delay period for significant buildings determined by the Arlington Historical Commission to be preferably-preserved from twelve months to two years. The Bylaw amendment does not seek to change the process by which demolition delays are imposed. Ms. Robinson noted that the Historical Commission has taken a vote of support on this warrant article.

The Board felt the proponent's amendment to increase the demolition delay period from twelve to twenty-four months was too long in light of the numerosity of properties on the historic registry that are already in need of certain repairs. The proponent acknowledged that historic home resources are scarce. Mr. DeCoursey asked if the proposal had any exceptions. Ms. Robinson noted that the demolition delay process currently addresses situations in which the full delay is inappropriate. The Board noted that twenty-four months was a longer delay compared to other municipalities, some of which have twelve, eighteen or possibly twenty-one-month demolition delays.

Jim Feeney, Town Manager

Mr. Feeney noted that before the Board is a request to consider calling a Special Town Meeting this Spring. This is necessary because the Attorney General's Office has identified a procedural flaw that needs to be cured with respect to Article 12 MBTA Communities Zoning Bylaw that was approved by Special Town Meeting in October. Specifically, the vote language considered by Town Meeting in October did not explicitly reference a zoning map that contains the multifamily housing overlay districts. Mr. Feeney noted that the vote language reference all of the associated textual bylaw amendments but did not

reference amending the zoning map with Arlington's proposed section districts. Mr. Feeney stated that we are being asked to address this technicality with more specifically crafted language to accurately capture the vote for the record.

Mrs. Mahon moved to call a Special Town Meeting on Wednesday, May 8, 2024, at the Arlington Town Hall at 8:00p.m. SO VOTED (5-0)

WARRANT ARTICLE HEARINGS

11. Articles for Review:

Article 14 Bylaw Amendment/Focused Residence Picketing

Mr. Feeney stated that this Article, if approved by Town Meeting, would make it unlawful for any person to picket "before or about" the residence or dwelling of any individual in the Town. Mr. Feeney noted that there have been multiple targeted demonstrations outside of the Governor's private residence to date. Some of these have had significant impacts on the neighborhood as a whole, especially those that have occurred late in the evening. Mr. Cunningham noted that according to a prior decision of the United States Supreme Court, the language of the proposed Bylaw Amendment strikes the correct balance between the protection of a citizen's First Amendment right to free speech and the right of privacy all citizens enjoy within their own walls, which the state may legislate to protect, seeking to ensure the ability to avoid intrusions of unwanted speech, because there is no right to force speech into the home of an unwilling listener.

Chief Flaherty provided the Board with information on three protests that have taken place in front of the Governor's residence, the second and third of which resulted in numerous calls to the Arlington Police Department. The first was planned and was peaceful. The second was unplanned and involved 25-30 people wearing military gear who were directly in front of the Governor's residence, holding flares, chanting and yelling obscenities at neighbors. Chief Flaherty also noted that the protest lasted for about twenty minutes and dispersed thereafter. The third protest was similar to the second protest. Both unplanned protests resulted in calls to 911 and to the Department's business line, some of which indicated that the protest was blocking roadways and, in one instance, required police assistance to allow a neighbor to exit their driveway. Mr. Cunningham cited specific case law in *Frisby v. Schultz* which is a 1988 US Supreme Court Case.

The Board had a robust discussion regarding this warrant article. The Board recognizes the balance between important First Amendment free speech rights and the significant

government interest in a person's right to privacy in their home. The majority of the Board believes the balance favors residential privacy and further notes that the Supreme Court drew a distinction between the home and an office for purposes of First Amendment protection. The Board notes that a restriction on targeted picketing applies at all times in Brookline, while is enforced between 9 pm and 9 am pursuant to a City of Boston ordinance. The two focused demonstrations in Arlington that were reported by state and local media occurred at different times but were equally disruptive. The majority of the Board supports a full ban similar to the bylaw approved in Brookline.

Towns and cities in Massachusetts that have voted affirmatively to submit similar home rule petitions to lower the minimum voting age for their local elections include Concord, Boston, Brookline, Somerville, Cambridge, Lowell, Southborough, Acton and Northampton. Ms. Shen stated that young people across the state are leading critical community engagement, advocacy, and policy efforts on many issues, including to climate and environmental crises, social injustices and inequities, public health issues, and barriers to civic engagement. Mr. Cunningham noted that pending legislation does not preclude the proponent's efforts to pursue this home rule petition that would apply only to Arlington.

The Board had a robust discussion about this article. Ms. Shen explained that she collected signatures for a petition in support of Article 22 from both students and teachers. Further, that students are eager to be more engaged in politics and passage of special legislation lowering the voting age to 16 in local elections would serve that purpose. Ms. Mahon noted that the proposed special legislation was for local elections only, which was most appropriate at this time.

Article 53 Appropriation/Takings for Stratton School Safe Routes

John Alessi appeared before the Board to present this warrant article. This Article seeks approval from Town Meeting for the Select Board to take or otherwise acquire, by eminent domain, purchase, donation or any other means, land in and around the Stratton Elementary School area for the purpose of placing sidewalks near the school in connection with the Commonwealth's Safe Routes to School program. The authorizing vote from Town Meeting is required by the Massachusetts Department of Transportation's Right of Way Bureau. Mr. Alessi noted this project is the result of The Town of Arlington's receipt of a Massachusetts Department of Transportation (MassDOT) Safe Routes to

School (SRTS) Project Award to fund safe roadway crossings near the Stratton Elementary School. Mr. Alessi stated that the proposed project will provide a fully accessible walking route with safe roadway crossings for children and others walking to Stratton along Hemlock Street between Brattle Street and Dickson Avenue and Dickson Avenue between Hemlock Street and Pheasant Avenue. If authorized, the Town will conduct all property acquisitions, including eminent domain takings, purchases, donations, permanent easements, or by any other manner, portions of land required for the project in full procedural compliance with applicable state and federal laws

Mr. Helmuth clarified that the Board is being asked to vote on the right of way process, and an affirmative vote on this Article by Town Meeting would require future Board votes on specific takings or acquisitions. The Board was informed that the MassDOT grant set forth specific guidelines for easements that required compensation to affected property owners.

RE: Lockeland Avenue Loading Zone

This memorandum summarizes Town Staff's review of the developer-proposed loading zone on Lockeland Avenue adjacent to the 882-892 mixed-use development.

In February 2024, the developers of the mixed-use development at 882-892 Mass Ave reached out to Town Staff to formally request a loading zone on Lockeland Ave. Although not required as part of their ARB Special Permit (Docket No. 3625, July 20, 2020), the developers explained that the proposed loading zone would be needed for ongoing delivery services.

Staff assessed the project area and noted that the Traffic Rules & Orders include an existing *No Parking* regulation on the west side of Lockeland Ave. from the corner of Mass Ave. to the former building's driveway. However, during the new development's construction, the *No Parking* signage was removed and never re-installed. Arlington Police indicated that the lack of signage has resulted in vehicles parking in the prohibited area, causing visibility concerns at the street corner and crosswalk.

After analyzing the project area, staff provided several rounds of comments on the engineering plan. The following changes were requested:

- Designate the *Loading Zone* signage as being limited to 30-minute commercial parking.
- Re-install *No Parking* signage in the area between the crosswalk at Lockeland Ave. and the loading zone, where a *No Parking* regulation currently exists.
- Remove the existing stop line and move it a distance of 4ft away from the Lockeland Ave. crosswalk, in line with the Transportation Advisory Committee's Crosswalk Standard dated April 28, 2004.

- Install a double yellow line from the new stop line to the development's driveway on Lockeland Ave., which will help delineate the loading zone from the two vehicle lanes.

The enclosed engineering plan for the loading zone encompasses all of the aforementioned requests and staff have determined that the loading zone would pose no issues to traffic and safety. It should also be noted that the developers would be fully responsible for installation costs and construction tasks.

If the Board were to approve the installation of this loading zone as proposed by the developers, it is recommended that they take the following actions:

1. Approve the design of the loading zone and the associated roadway improvements as indicated in the enclosed engineering plan.
2. Amend Schedule I: Parking, of the Town of Arlington Traffic Rules and Orders, as indicated below.
Note – The No Parking Regulation on the west side of Lockeland Ave. has been adjusted to encompass the length between Mass Ave. and the proposed loading zone.

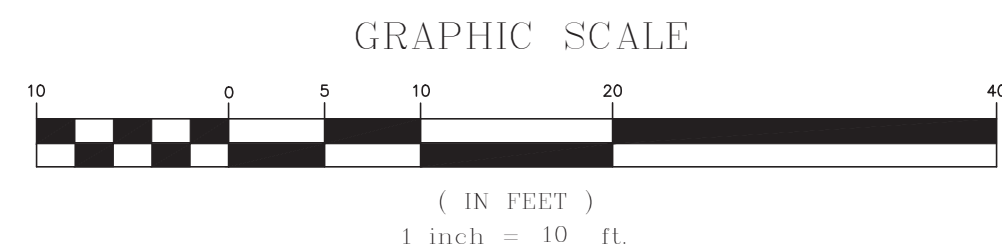
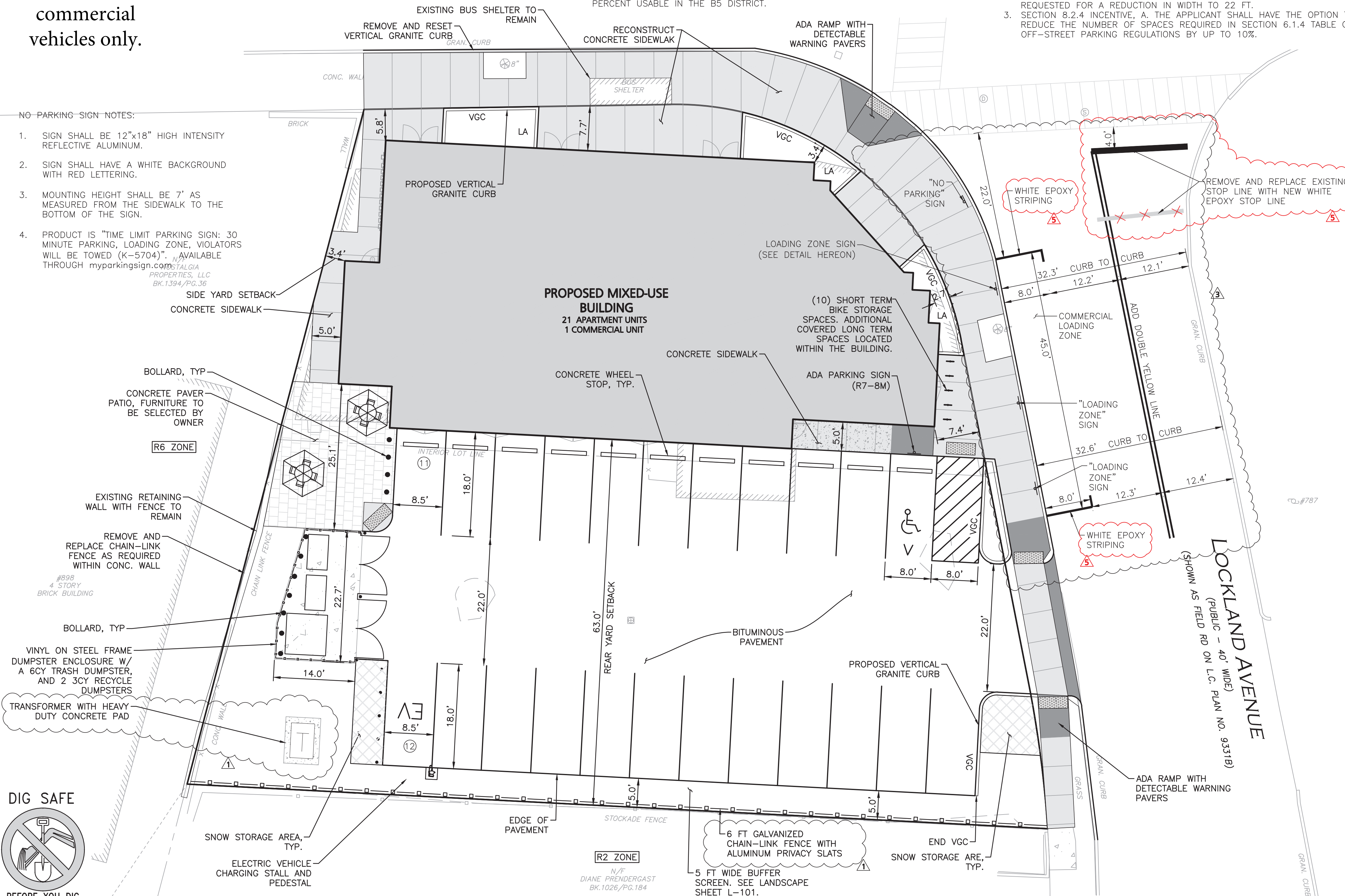

The Legal Department writes to provide the Select Board a summary of the above referenced warrant articles to assist in your consideration of these articles at your upcoming hearing on April 24, 2024.

**ARTICLE 2 BYLAW AMENDMENT / AMEND THE POET LAUREATE
SCREENING COMMITTEE MEMBERSHIP**

To see if the Town will vote to amend the membership of the Poet Laureate screening committee to automatically allow the previous Poet Laureate to be a member of that committee and to increase or decrease the number of members on the committee; or take any action related thereto.

(Inserted at the request of the Poet Laureate Screening Committee)

This Article was inserted at the request of the Poet Laureate Screening Committee. It is expected that a representative from the Poet Laureate Screening Committee will present the reasoning for the submission of the proposed Bylaw amendment at the public hearing on this Article. However, it is noted that the honorary position of the Poet Laureate of the Town of Arlington was created by the 2014 Annual Town Meeting. At that time, the Select Board wrote in its report to Town Meeting that it strongly supported “the establishment of a voluntary and honorary Poet Laureate position for Arlington, continuing the Town’s support of and commitment to the arts. Members of the Board and the public voiced universal support for both recognizing and fostering the literary arts works of Town residents.”

The governing provisions for the Poet Laureate position in Arlington are set forth in Title II, Article 11 of the Town’s Bylaws. Section 2 of the Article indicates that the Poet Laureate is appointed by a screening committee consisting of five persons. The current proposed bylaw amendment would keep the screening committee’s membership at five members, but would change the membership to allow for a designee of each screening committee member to serve in that member’s place, and also replaces the member appointed by the Town Moderator to a former Poet Laureate, or a town meeting member (appointed by the Town Moderator) if no former Poet Laureate is available.

If the Select Board approves favorable action, a draft motion that could be sent to the Town Meeting may read as follows:

VOTED: that the Town does and hereby amends Title II, Article 11 of the Town’s Bylaws, or take any action related thereto, so that the new provision of Title I reads as follows:

Title II
ARTICLE 11
POET LAUREATE OF ARLINGTON
(ART. 13 – ATM – 4/30/14)

Section 1. Establishment of an Honorary Poet Laureate of Arlington

There is hereby established for the purposes of advancing the literary arts, enriching the community, and recognizing the literacy achievements of Town residents, the honorary position of Poet Laureate of Arlington.

Section 2. Selection, Term and Criteria

Appointment of a Poet Laureate shall be for a term of one year, annually renewable for a total of three years based on the recommendation of a screening committee of five persons consisting of: ~~one person each designated by:~~

- (a) A designee of ~~the~~ Library Board of Trustees (by majority vote);*
- (b) A designee of ~~the~~ Arlington School Committee (by majority vote);*
- (c) A designee of ~~the~~ Arlington Commission on Arts and Culture (by majority vote);*
- (d) ~~Town Meeting Member (appointed by the Town Moderator)~~ A former Poet Laureate starting with the most recent or a Town Meeting Member (appointed by the Town Moderator) if no former Poet Laureate is available;*
- (e) A designee of ~~the~~ Town Manager (with advice and consent of the Select Board).*

~~and confirmed by the Select Board.~~ All members shall be confirmed by the Select Board.

This honorary position shall be voluntary. Only Arlington residents shall be considered for appointment, and any person appointed as Poet Laureate of Arlington must at all times remain an Arlington resident during their term as Poet Laureate. In the event that a Poet Laureate is no longer a resident of Arlington during their term, the honorary position shall be construed to have been constructively vacated.

Section 3. Duties of Poet Laureate

The duties of the Poet Laureate shall be to present original works of poetry, conduct readings and participate in public events and Town, public school and library programs as appropriate and practicable

ARTICLE 5 RESOLUTION FOR A CEASEFIRE PROCLAMATION

To see if the Town will vote to adopt a proclamation in favor of an immediate and permanent ceasefire in Palestine and Israel, the release of all hostages, the immediate provision of lifesaving aid, and a diplomatic resolution for Palestinians and Israelis based upon the values of dignity, equity, and justice; or take any action related thereto.

This Article was inserted by Chadi Salamoun and one hundred registered voters. This Article seeks a non-binding resolution of Town Meeting to support a call for a ceasefire proclamation in Palestine and Israel. It is expected that the proponent will provide further details on the goals and details of the proposed resolution at the hearing on the Article.

ARTICLE RESOLUTION FOR A CEASEFIRE PROCLAMATION

To see if the Town will vote to adopt a proclamation in favor of an immediate and permanent ceasefire in Palestine and Israel, the release of all hostages, the immediate provision of lifesaving aid, and a diplomatic resolution for Palestinians and Israelis based upon values of dignity, equity, and justice; or to take any action related thereto.

PROCLAMATION

WHEREAS, the Town of Arlington recognizes that all human life is precious, regardless of race, ethnicity, color, religious views, national origin, sex, gender identity or expression, citizenship, age, ancestry, sexual orientation and/or ability/disability, and that the targeting of civilians is a violation of international humanitarian law; and,

WHEREAS, since October 7, 2023, at least 1,200 Israelis and 33,000 Palestinians have been killed, and civilians have been deliberately targeted and continue to suffer greatly; and,

WHEREAS, hostages continue to be held captive without regard to their legal and human rights; and that thus far, the only successful effort to secure the release of a large number of hostages was through an agreed upon ceasefire in November 2023; and,

WHEREAS, the ongoing violence has also led to the displacement of more than 135,000 civilians in Israel and 90,000 civilians in Lebanon; and,

WHEREAS, the ongoing military campaign and blockade of Gaza has caused a catastrophic humanitarian crisis, including the repeated displacement of more than 1.9 million people, the overwhelming destruction of the healthcare system and civilian infrastructure, and widespread hunger and famine; and

WHEREAS, international organizations such as Amnesty International, the United Nations, the World Health Organization, the US Agency for International Development (USAID), the International Rescue Committee, and many others, have made a call for a ceasefire in order to avert further loss of civilian life and to be in accordance with international humanitarian law; and,

WHEREAS, the continuing violence undermines the international order, has already killed at least four US military personnel, is central to a series of escalations that endangers civilians and US military personnel, and risks a wider war; and,

WHEREAS, taxes paid by Arlington residents are contributing to the ongoing violence and humanitarian suffering of Palestinian civilians; and,

WHEREAS, Arlington's Palestinian, Israeli, Jewish, Muslim, and Arab residents, among others, are experiencing trauma, grief, shock, and fear, compounded by increased incidents of Islamophobia, antisemitism and anti-Palestinian hate, both nationally and locally; and,

WHEREAS, we, as members of the Arlington community, must first acknowledge the particular and directly experienced pain, suffering, and anger of those among us who are most impacted by the current circumstances in Israel, Gaza, and the West Bank, and also recognize the clear impact on all members of the Arlington community as we witness the increasing scale of violence and suffering in the region;

NOW, THEREFORE, BE IT RESOLVED that the Town of Arlington supports an immediate and permanent ceasefire across all of Gaza, the West Bank, Israel, and neighboring countries; and,

BE IT FURTHER RESOLVED that the Town of Arlington unequivocally condemns deliberate attacks on civilians and thereby calls for the release of all hostages and the uninhibited provision of life-saving humanitarian aid to Gaza; and,

BE IT FURTHER RESOLVED that the Town of Arlington supports a diplomatic solution for Palestinians and Israelis based upon the values of dignity, equity, justice, and international law; and,

BE IT FURTHER RESOLVED that the Town of Arlington urges the Biden Administration, the Senate, and the House of Representatives to commit to an immediate and permanent ceasefire, the release of all hostages, the immediate provision of all life-saving aid, and a diplomatic solution for Palestinians and Israelis based upon international law; and,

BE IT FURTHER RESOLVED that a copy of this resolution be sent to the offices of The President of the United States, Joseph Biden, Senator Elizabeth Warren, Senator Ed Markey, and Congresswoman Katherine Clark; and,

BE IT FURTHER RESOLVED that through the passing of this resolution, this Town Meeting collectively condemns all forms of racism, bigotry, and discrimination, and furthermore, that we extend our support to members of our Arlington community who are affected by this crisis, and furthermore, that we reaffirm our commitment to those bodies in Arlington which have specifically been created to foster a more equitable, just and liveable community for all in Arlington and beyond.

Arlington Human Rights Commission

Report on April 2024 Listening Sessions

Background

During the Arlington Human Rights Commission (AHRC) meeting on March 20th, a number of community members attended and spoke in person or via Zoom about the ongoing destruction of life in Gaza, the widespread impact on children, reports of large-scale starvation, and the deaths of humanitarian aid workers. People spoke about the impact they felt due to personal connections, the increase in hate and rhetoric due to this war, and the importance of presenting a humanitarian viewpoint. Many appealed to the AHRC to respond appropriately and urgently, stating doing so makes people feel included and welcomed.

To consider a response, the AHRC scheduled a Special Meeting on April 1st to discuss this appeal from members of the community as well as to discuss the co-signing of a statement by another community affirming the rights of Palestinian, Arab & Muslim members of the community.

At that meeting, it was decided to hold listening sessions to gather feedback from the broader Arlington community, to answer two questions specifically:

- As an impacted member of the community, how might *other community members* make you feel more welcome, safe, and valued in Arlington?
- How might the *AHRC itself* take action to make you feel more welcome, safe, and valued in Arlington?

The intent was to identify ways the AHRC could help respond to the impact here in Arlington due to the humanitarian crisis continuing to unfold in and around Gaza.

Listening Sessions

The listening sessions were organized with the goal in mind to collect as much feedback as possible within a short period of time to be able to review, assimilate, and discuss feedback before the next AHRC meeting on April 10th. In an attempt to accommodate as many individuals and schedules as possible, we planned four separate sessions at different time slots: Thursday, 4/4, Friday, 4/5, Saturday, 4/6, and Monday, 4/8. Each session was attended by multiple members of the Commission as facilitators and notetakers. Members of the DEI department - Jillian Harvey, Teresa Marzilli, and Colleen Leger of Health and Human Services (HHS) - were also in attendance for technical coordination. Additionally, the AHRC asked people to submit written submissions to let their voices be heard if they could not attend any of the time slots listed above. These sessions were advertised via Town notice emails, the AHRC distribution list/website, and social media channels, including a variety of Arlington Facebook groups.

Feedback

The AHRC is grateful to the approximately 100 community members who spoke at the listening sessions, and those who sent over 100 emails to the AHRC before and immediately after the listening sessions, to share their stories at emotional and personal risk to themselves.

There were several notable and inspiring ideas for our community, including the following:

- Establishing a sister city in Palestine and Israel
- Hosting forums to encourage discourse and harmony
- Hold teach-ins to discuss history and increase tolerance
- Host food festivals to bring people together with a focus on unity and to promote cross-cultural understanding
- Create reading lists with input from libraries
- Create a “welcome to the town” packet that includes information about town government, civic participation and welfare programs, and promotion of local businesses.

Some common themes that were mentioned during the listening sessions were:

- Urgent calls to draft a ceasefire resolution based upon the severe humanitarian crisis in Gaza that affects a wide number of residents who are of different religions, ethnicities, and racial identities; due to the historical marginalization of Palestinian people, linked to the extensive US military & diplomatic support, and the need to speak up in a participatory democracy.
- Urgent calls to not draft a ceasefire resolution due to issues related to personal safety within Arlington, targeting of the only Jewish nation-state, linking to the traumas of the

Holocaust and pointing to the October 7 attacks as the reason for the crisis, and questioning if this falls within the purview of the AHRC.

- A number of residents requested the need for a balanced proclamation highlighting victims in Israel, destruction in Gaza, victims of Jewish, Muslim, and Christian faiths, and a call to release all hostages and prisoners and to appeal to humanity.
- Forums to respond to Islamophobia and antisemitism incidents in the town.
- A need for the AHRC to focus solely on local issues.

Many within the community were thankful to the AHRC for providing listening sessions, and some of the positive comments included:

- Appreciation for the effort involved in scheduling and hosting the listening sessions.
- An appreciation of past statements released by the AHRC on local and foreign human rights issues that make people feel included.
- Being responsive to calls from the community to respond to the crisis in Gaza.
- The opportunity to have a forum for comment, a place to be heard.

There were many critical comments about the listening sessions, and some of the notable points were:

- Pointing to the limits of AHRC's scope.
- Questioning the competence of the AHRC to comment on foreign issues.
- Not responding to antisemitic incidents in schools or in town.
- Hosting 2 of the listening sessions during the Sabbath/Shabbat.
- Questions about who is being heard in Arlington.
- Lack of responsiveness to other foreign crises.
- Concerns about the process, absence of trained facilitators, and lack of widespread publicity.
- Comments leading to an echo chamber of conflicting opinions.
- Comments about ending some sessions earlier than the stated end time.

Specifically related to the objective of the listening sessions, there was an emphasis on how the events in Israel and Gaza have impacted residents' lives in Arlington. The AHRC heard many stories of death, loss, and hopelessness from our Muslim, Arab, and Palestinian neighbors. Also heard were many stories of death, loss, and violence from our Jewish and Israeli neighbors. The AHRC was informed unequivocally that there is a pervasive sense of dehumanization and stigma surrounding religious identities that has affected members of those groups' perception of their safety here in town. The AHRC was also warned about fear of further escalation absent acknowledgement and intervention.

There were mentions of dehumanizing narratives all too common in toxic online discourse being lobbied against other groups, neighbors, and even members of the AHRC. Some of the comments included:

- Dehumanizations of Palestinians with descriptors of being a collection of tribes.
- Dismissal of a pro-Israel viewpoint as Zionist and questioning of the seriousness of antisemitic incidents in Arlington.
- Comments about Israeli victims of attacks being referenced only by people of the Jewish faith.
- Mentions of posters of October 7 hostages being torn down.
- A threat of legal action against the AHRC.
- An accusation of using antisemitic tropes and writing biased statements.
- Mentions of dehumanizing terms towards fellow Arlington residents, such as mob mentality.

After significant deliberation during the public AHRC Special Meeting on April 10th, the AHRC decided not to issue a ceasefire proclamation of its own, since that contravenes recently adopted AHRC policy against issuing statements that do not directly concern issues in Arlington.

As such, in the AHRC's desire to better serve its mission of response and education to human rights-related issues here in Arlington, the AHRC will consider the following in response:

- **Continue to convene and co-sponsor opportunities for community conversation, cultural celebration, and education, such as:**
 - Eid Mubarak event organized by the Arlington High School (AHS) Muslim Student's Association on 4/19
 - Neighbors Eating All Together (NEAT) dinner sponsorship on 4/13
 - Day of Learning, focused on building welcoming communities featuring RefugePoint on 2/10
- **Convene and co-sponsor future opportunities for conversation and education in response to Islamophobia and antisemitism, such as:**
 - Planning for a vigil or an event to address antisemitism
 - Considering cosigning a statement to affirm Arab and Muslim human rights
 - Upcoming educational session
- **Empower a new special working group of the AHRC specifically focused on promoting religious tolerance, safety, and understanding;** joining the AHRC's three other working groups, this team shall meet regularly for the duration of at least the next year to monitor and respond to incidents and the climate of religious hate in the town.
- **Provide education and awareness regarding the 2024 Special Town Meeting warrant articles related to religious violence;** the AHRC routinely provides

commentary on submitted Town Meeting warrant articles related to their impact on human rights. Submitted by community members for the 2024 Special Town Meeting, Article 5 will ask Town Meeting Members to vote on whether to issue a proclamation urging a bilateral ceasefire.

- **Review our bylaws to determine the exact scope of the AHRC in terms of making statements and comments about human rights violations around the globe;** the AHRC will break down and analyze the mission and bylaws to determine scope and purpose to guide future response, events and agendas.

Dear members of the Select Board of Arlington,

My name is Lauren Kleutsch, and a resident of Arlington for the past ten years, along with my husband and two children. I am proud to live in this town for many reasons, among them the town's commitment to human rights and social justice.

I am writing to request that the Select Board vote in favor of a proclamation calling for an immediate and permanent ceasefire in Gaza. I don't see how any moral person can stand aside and watch as innocent civilians, among them children the age of my own, continue to be killed in horrific ways, while others witness their family and friends murdered in front of them.

Support for a ceasefire resolution would mean a great deal to the Palestinian and Palestinian-American citizens of Arlington, as well as other Muslim residents. I believe that this is an important signal of our community's commitment to racial and social justice.

I have heard from some folks that they worry that a ceasefire resolution is antisemitic. I want to challenge that framing, and explain why it is faulty logic to equate support for a permanent ceasefire with antisemitism.

I'm a public school teacher: I teach English as a Second language to immigrants and children of immigrants in upper elementary grades. As an educator, I see my role as helping children learn *how* to think, rather than simply *what* to think. We spend a lot of time engaged in critical debate, with students challenging one another's logic and expecting one another to explain their reasoning. I work to encourage nuance and complexity in their thinking. One of the phrases I use to help them understand how to go about that is, "two things can be true." That is, seemingly opposing facts or perspectives can exist simultaneously.

With a framework of "two things can be true," I want to remind you of the following:

You can have enormous empathy for the 1,200 Israeli victims of the October 7th attack AND reject the notion that the events of that day justify the disproportionate response by Israel that has killed over 30,000 Palestinians, among them 10,000 innocent children. You can want the return of the hostages held by Hamas, while also believing that blocking the delivery of food and medical aid, destroying medical facilities, and targeting humanitarian aid workers is cruel. You can even be a Zionist, and believe in Israel's right to exist, and STILL take issue with the IDF's relentless violence against Palestinian civilians.

My point is here that you can set aside political questions about who has the original claim to the land, to speak out against what is undeniably a violation of international human rights. To support a ceasefire proclamation is not antisemitic, and those who would have you believe that its are engaging in a logical fallacy. To support a ceasefire is to stand up for international human rights, and to be on the right side of history. That is what our town must do.

Dear Members of the Select Board,

My name is Christina Ahmad. I am originally from Lowell, MA and have resided in Arlington with my husband and young children for 10 years. I'm writing to convey the significance of an Arlington ceasefire resolution from the perspective of a proud American, parent, and Christian.

Although my family is American of Palestinian descent through my husband, the reason I believe it is worthwhile for Arlington to issue a ceasefire resolution is to pressure our elected officials to quit slow walking our nation, the United States of America, into a world war. The consequences of escalating the war on Gaza will be long-lasting for Americans who will have had their economic, military, and political might stolen by foreign interests and powerful elites. Furthermore, it is American sons and daughters who will be on the front lines giving their lives in a war that will destroy America's credibility and open our nation to retaliatory attacks. American troops are already in harm's way as they sit in bases across the Middle East, including in the country of Jordan where I have observed the massive U.S. military presence myself.

My concern is also for Gazans, so many of them children, who are suffering catastrophic losses and are in imminent danger to life and limb. As a parent, it is abhorrent to me that American wealth and influence is being used to punish Palestinians who have committed no crime against the United States of America. An estimated 14,000 children have been killed. About 1,000 have had limbs amputated as the result of airstrikes. Scores more have been badly maimed. The deaths include 7 children at St. Porphyrios Greek Orthodox Church who were crushed under a building on the church grounds with 11 members of their family in a confirmed Israeli airstrike after the IDF learned the church was giving shelter to Muslims neighbors in addition to parishioners.

I wish everyone had the opportunity to spend time with Palestinian families, as I have, to see how very committed and gentle the fathers are to their children. Palestinian men in Gaza are presumed to be terrorists by virtue of their age and gender and are marked for execution. The loss of the father is catastrophic for families. So, too, is the death of the mothers, many of them pregnant. Breastfeeding women have been killed in airstrikes, the babies losing their mother and her milk. I have seen children screaming for their dead mothers to come back. The trauma of those losses will haunt Palestinian children and the world order for decades to come.

At Holy Family Catholic Church, a mother and daughter were murdered by Israeli snipers as they crossed the church compound's courtyard on their way to the bathroom. Another woman sheltering at the Catholic church was shot in the leg by an Israeli sniper. Members of the church who tried to help her were shot at as well. She bled to death on the road overnight.

It is not lost on me, a Greek Orthodox Christian resident of Arlington, that the political class of the United States watches as Christians disappear from the Holy Land. It is chilling that the justification for not saving our Christian brethren is that the existence of Palestinians threatens the safety of Jewish people, or that our Jewish neighbors feel threatened by assertions that the people of Gaza deserve life and aid.

Please allow the residents of Arlington to put on record for our elected representatives the urgent need to preserve life and liberty with a ceasefire in Gaza. The wellbeing of our town and nation depends on it.

Dear Members of the Arlington Select Board,

I have been to Palestine once, in 2016, as part of a delegation organized by Interfaith Peace Builders (now Eyewitness Palestine). Our hosts were both Israelis and Palestinians who were striving for an end to the systemic mistreatment of the indigenous people. In one of our many stops, we saw how water was being redirected to a settlement, leaving little if any for the nearby village. In Hebron we saw a net in a market area which Palestinians had put up to block and collect the garbage thrown down at them by the settlers living above.

Two of us in the delegation arrived half a day early, and were sitting outside a cafe, around the corner from our hotel in E. Jerusalem. An elderly Arab man approached us and warmly welcomed us to Jerusalem. By coincidence, he turned out to be a friend of (now) my partner Patricia, who has traveled to Palestine many times. "Haj Ibrahim" as he is called, lives in the Mount of Olives region. His Bedouin family has lived there for hundreds of years and have a tradition of welcoming visitors to the city. For years Ibrahim hosted them at his ancestral "Peace House" - giving them a place to sleep and some food for several days, for free. Now in his 80s, he added a second floor, for himself and his wife, to a home he had built for his son, some years ago. The Israeli municipality fined him several hundred thousand dollars for permit violations (a common way of harassing Palestinians). Of this he can pay but a fraction, and is being threatened with prison. Home demolition is a recurring menace. He's frequently in court and the stress has taken a serious toll on his health. Both of his parents lived past 100, but he is unlikely to. He calls occasionally to say hello, and we hear of his latest mistreatment.

Ibrahim's mistreatment is a travesty but it pales next to what is happening in Gaza. Anyone with a television knows of the ongoing slaughter, courtesy of the U.S. taxpayer.

Yesterday, April 23, however, marks (perhaps) a new low in our involvement. Congress approved a \$26B "aid" package for Israel, of which \$17B is for weapons and other military provisions. That amounts to over **\$2600 for every Israeli man, woman and child**. Yet Israel is a wealthy country, ranking #11 in per capita - better than Canada, Germany and the UK.

There is much more than financial incongruity involved in this giveaway. The death and destruction inflicted on Gaza is being done as much by our hand as by that of Israel. The outrage around the world is certain to backfire on us eventually. (Recall 9-11.)

Domestically, we are seeing an outpouring of anger against the Biden administration, coming from the Democratic base (75% of which disapproves of Biden's Gaza policy), especially younger people. The resulting alienation could well cost Biden the election in November. **This will affect every one of us in Arlington.** And the blame will lie not on "spoilers" or those who sit out the election, but rather on Biden's genocidal policy in Gaza.

I urge the Select Board to favorably recommend the *Resolution for a Ceasefire Proclamation*.

Dear Members of the Arlington Select Board,

I wrote to the Arlington Human Rights Commission on March 31st and also spoke at the April 8th listening session. I will summarize and expand a bit on a few of the points I made in that letter and at the session. Moreover, I feel obliged to respond to several statements made by other speakers during the April 8th and prior listening sessions.

Simon Proekt asserted that a statement re Ceasefire in Gaza is outside the scope of the AHRC. I disagree. Human rights are universal and indivisible. They cannot be ignored in the national or world context without rendering them empty when applied locally. Indeed the AHRC website states (re Ongoing Repression of the Muslim Community in India):

As a home to many people with connections across the world and as a community that wants to contribute to global conversations, Arlington cannot ignore issues that seriously affect human rights around the world.

I believe Mr. Proekt also stated that a proclamation by the Commission would have little if any consequence in Gaza. It can be said that our individual votes have little effect on elections. Should we therefore not bother to go to the polls? A ceasefire proclamation would amplify similar statements passed in many Massachusetts *cities* and be the first in one of its *towns*. (I believe Mr. Proekt later wrapped himself in an Israeli flag during the Zoom session – an ironic, if not comic touch, given his contention that foreign events were outside the scope of those sessions.)

Claims of skyrocketing anti-Semitism were made on April 8th. Unfortunately, there has been an ongoing effort for years to equate this deplorable sentiment with criticism of the state of Israel. A “working definition” of anti-Semitism, drafted by American Jewish Committee (AJC), under the banner (contested, incidentally) of the International Holocaust Remembrance Alliance (IHRA) explicitly does this. The “IHRA definition” has been pushed through some state legislatures, despite its lead author (Kenneth Stern) decrying its use in this way. Consequently, when Israel acts in deplorable or criminal ways, criticism of it and therefore (alleged) “anti-Semitism” increases.

We heard related logic that night from a speaker who insisted that Israel and “Jews” were inseparable. I have *many* Jewish friends who would counter that such a linkage is *itself* fundamentally anti-Semitic. For it effectively places responsibility for Israel’s actions on the shoulders of *all* Jews. (Historical note: the AJC itself was once anti-Zionist.)

Israel has been accused of plausible genocide (ICJ ruling) and many around the world, including in this country, consider it to be actual genocide. But I find this inaccurate. Rather *the United States and Israel* are committing genocide in Gaza. The ongoing massacre in Gaza would not be possible without the weaponry and aircraft to deploy it provided by the U.S. and, even more important, the political cover provided in the UN through numerous U.S. vetoes of Security Council resolutions, including for ceasefires. What makes this more horrific is that it is being done to a trapped people. I have followed politics for most of my life, and can recall nothing comparable to the viciousness of this slaughter. And I can think of few things more likely to fuel hatred of Israelis, Americans, and Jews, around the world, especially in the Global South (which, incidentally, surrounds Israel).

The preposterous assertion was made that the “IDF” is exemplary in its efforts to avoid civilian casualties. This can only make sense in an “inverted world” where evil is good and genocide is acceptable. Many eyewitnesses and numerous media sources have documented the intentional carnage, devastation, killings of journalists, and imposed starvation being inflicted on Gaza.

We hear repeatedly that Hamas is a terrorist organization. It certainly uses the methods of “asymmetric warfare” and, *to be sure, the murder and kidnapping of civilians is a war crime*. Recall, though, that three of Israel’s founders (Ben Gurion, Begin and Shamir) were the leaders of terrorist militias (Haganah, Irgun and Stern Gang, respectively). These organizations committed innumerable terrorist acts and atrocities, including the assassination of British Lord Moyne (1944), the bombing of the King David Hotel (1946), the assassination of Count Bernadotte and the slaughter of between 110-250 people in Deir Yassin and (both in 1948), to name just a few. (Ironically, Bernadotte had been instrumental in saving thousands of Jews during the Holocaust but these actions didn’t spare him.) Following the declaration of the State of Israel in 1948 these three terrorist militias merged into a single military entity. Right; it is called the Israeli *Defense Force*.

The discussion at hand is inextricably tied to the “Palestine question”. The literature and commentary on the latter are voluminous, and I have attached several short documents of interest. Revisionist (i.e., political) Zionism appears on the historical stage in the 1920s. Its founder, Ze’ev Jabotinsky, wrote a key document, *The Iron Wall* (1923), explaining that Zionism was a settler colonial project, and that the “native population” would resist it with “ferocity”. Its scant 7 pages comprise an instructive read. (Jabotinsky was at least honest.)

I’ve also attached an excerpt from another key historic document, the British Peel Commission report of 1937. The latter describes the motives behind the British Balfour Declaration of 1917 – a *quid pro quo*, promising Palestine to the Zionists in exchange for support from American Jews for the British war effort – which was not going well at the time of the Declaration’s conception.

And I’ve attached a famous open letter, published in 1948 in the New York Times, by Albert Einstein, Hannah Arendt, Sidney Hook, and 24 other Jewish intellectuals, decrying Revisionist leader Menachem Begin’s *Herut* party as akin to Nazi and Fascist parties. *Herut* was later re-branded as Likud, the party of Netanyahu.

In the words of William Faulkner: “The past is never dead. It isn't even past.”

On February 25th, shortly before immolating himself in protest of the ongoing massacres in Gaza, Air Force serviceman Aaron Bushnell posed a question for all of us: “What would I do if my country was committing genocide?” The answer is, you're doing it. Right now.”

As our country drives itself deeper and deeper into a moral abyss, to which our Congress appears oblivious, citizens and local governments must speak out. **Accordingly, I urge the Select Board to approve a town proclamation calling for an immediate and permanent ceasefire in Gaza.**

Colonisation of Palestine

Agreement with Arabs Impossible at present

Zionism Must Go Forward

It is an excellent rule to begin an article with the most important point. But this time, I find it necessary to begin with an introduction, and, moreover, with a personal introduction.

I am reputed to be an enemy of the Arabs, who wants to have them ejected from Palestine, and so forth. It is not true.

Emotionally, my attitude to the Arabs is the same as to all other nations – polite indifference. Politically, my attitude is determined by two principles. First of all, I consider it utterly impossible to eject the Arabs from Palestine. There will always be *two* nations in Palestine – which is good enough for me, provided the Jews become the majority. And secondly, I belong to the group that once drew up the Helsingfors Programme, the programme of national rights for all nationalities living in the same State. In drawing up that programme, we had in mind not only the Jews, but all nations everywhere, and its basis is equality of rights.

I am prepared to take an oath binding ourselves and our descendants that we shall never do anything contrary to the principle of equal rights, and that we shall never try to eject anyone. This seems to me a fairly peaceful credo.

But it is quite another question whether it is always possible to realise a peaceful aim by peaceful means. For the answer to this question does not depend on our attitude to the Arabs; but entirely on the attitude of the Arabs to us and to Zionism.



Now, after this introduction, we may proceed to the subject.

Voluntary Agreement Not Possible.

There can be no voluntary agreement between ourselves and the Palestine Arabs. Not now, nor in the prospective future. I say this with such conviction, not because I want to hurt the moderate Zionists. I do not believe that they will be hurt. Except for those who were born blind, they realised long ago that it is utterly impossible to obtain the voluntary consent of the Palestine Arabs for converting "Palestine" from an Arab country into a country with a Jewish majority.

My readers have a general idea of the history of colonisation in other countries. I suggest that they consider all the precedents with which they are acquainted, and see whether there is one solitary instance of any colonisation being carried on with the consent of the native population. There is no such precedent.

The native populations, civilised or uncivilised, have always stubbornly resisted the colonists, irrespective of whether they were civilised or savage.

And it made no difference whatever whether the colonists behaved decently or not. The companions of Cortez and Pizzaro or (as some people will remind us) our own ancestors under Joshua Ben Nun, behaved like brigands; but the Pilgrim Fathers, the first real pioneers of North America, were people of the highest morality, who did not want to do harm to anyone, least of all to the Red Indians, and they honestly believed that there was room enough in the prairies both for the Paleface and the Redskin. Yet the native population fought with the same ferocity against the good colonists as against the bad.

Every native population, civilised or not, regards its lands as its national home, of which it is the sole master, and it wants to retain that mastery always; it will refuse to admit not only new masters but, even new partners or collaborators.



Arabs Not Fools

This is equally true of the Arabs. Our Peace-mongers are trying to persuade us that the Arabs are either fools, whom we can deceive by masking our real aims, or that they are corrupt and can be bribed to abandon to us their claim to priority in Palestine, in return for cultural and economic advantages. I repudiate this conception of the Palestinian Arabs. Culturally they are five hundred years behind us, they have neither our endurance nor our determination; but they are just as good psychologists as we are, and their minds have been sharpened like ours by centuries of fine-spun logomachy. We may tell them whatever we like about the innocence of our aims, watering them down and sweetening them with honeyed words to make them palatable, but they know what we want, as well as we know what they do not want. They feel at least the same instinctive jealous love of Palestine, as the old Aztecs felt for ancient Mexico, and their Sioux for their rolling Prairies.

To imagine, as our Arabophiles do, that they will voluntarily consent to the realisation of Zionism. In return for the moral and material conveniences which the Jewish colonist brings with him, is a childish notion, which has at bottom a kind of contempt for the Arab people; it means that they despise the Arab race, which they regard as a corrupt mob that can be bought and sold, and are willing to give up their fatherland for a good railway system.

All Natives Resist Colonists

There is no justification for such a belief. It may be that some individual Arabs take bribes. But that does not mean that the Arab people of Palestine as a whole will sell that fervent patriotism that they guard so jealously, and which even the Papuans will never sell. Every native population in the world resists colonists as long as it has the slightest hope of being able to rid itself of the danger of being colonised.



That is what the Arabs in Palestine are doing, and what they will persist in doing as long as there remains a solitary spark of hope that they will be able to prevent the transformation of "Palestine" into the "Land of Israel."

Arab Comprehension

Some of us have induced ourselves to believe that all the trouble is due to misunderstanding – the Arabs have not understood us, and that is the only reason why they resist us ;if we can only make it clear to them how moderate our intentions really are, they will immediately extend to us their hand in friendship.

This belief is utterly unfounded and it has been exploded again and again. I shall recall only one instance of many. A few years ago, when the late Mr. Sokolow was on one of his periodic visits to Palestine, he addressed a meeting on this very question of the "misunderstanding." He demonstrated lucidly and convincingly that the Arabs are terribly mistaken if they think that we have any desire to deprive them of their possessions or to drive them out of the country, or that we want to oppress them. We do not even ask for a Jewish Government to hold the Mandate of the League of Nations.

One of the Arab papers, "El Carmel," replied at the time, in an editorial article, the purport of which was this:

The Zionists are making a fuss about nothing. There is no misunderstanding. All that Mr. Sokolow says about the Zionist intentions is true, but the Arabs know that without him. Of course, the Zionists cannot now be thinking of driving the Arabs out of the country, or oppressing them, not do they contemplate a Jewish Government. Quite obviously, they are now concerned with one thing only- that the Arabs should not hinder their immigration. The Zionists assure us that even immigration will be regulated strictly according to the economic needs of Palestine. The Arabs have never doubted that: it is a truism, for otherwise there can be no immigration.



No "Misunderstanding"

This Arab editor was actually willing to agree that Palestine has a very large potential absorptive capacity, meaning that there is room for a great many Jews in the country without displacing a single Arab. There is only one thing the Zionists want, and it is that one thing that the Arabs do not want, for that is the way by which the Jews would gradually become the majority, and then a Jewish Government would follow automatically, and the future of the Arab minority would depend on the goodwill of the Jews; and a minority status is not a good thing, as the Jews themselves are never tired of pointing out. So there is no "misunderstanding".

The Zionists want only one thing, Jewish immigration; and this Jewish immigration is what the Arabs do not want.

This statement of the position by the Arab editor is so logical, so obvious, so indisputable, that everyone ought to know it by heart, and it should be made the basis of all our future discussions on the Arab question. It does not matter at all which phraseology we employ in explaining our colonising aims, Herzl's or Sir Herbert Samuel's.

Colonisation carries its own explanation, the only possible explanation, unalterable and as clear as daylight to every ordinary Jew and every ordinary Arab.

Colonisation can have only one aim, and Palestine Arabs cannot accept this aim. It lies in the very nature of things, and in this particular regard nature cannot be changed.

The Iron Wall

We cannot offer any adequate compensation to the Palestinian Arabs in return for Palestine. And therefore, there is no likelihood of any voluntary agreement being reached. So that all those who regard such an agreement as a condition sine qua non for Zionism may as well say "non" and withdraw from Zionism.



Zionist colonisation must either stop, or else proceed regardless of the native population. Which means that it can proceed and develop only under the protection of a power that is independent of the native population – behind an iron wall, which the native population cannot breach.

That is our Arab policy; not what we should be, but what it actually is, whether we admit it or not. What need, otherwise, of the Balfour Declaration? Or of the Mandate? Their value to us is that outside Power has undertaken to create in the country such conditions of administration and security that if the native population should desire to hinder our work, they will find it impossible.

And we are all of us, without any exception, demanding day after day that this outside Power, should carry out this task vigorously and with determination.

In this matter there is no difference between our "militarists" and our "vegetarians". Except that the first prefer that the iron wall should consist of Jewish soldiers, and the others are content that they should be British.

We all demand that there should be an iron wall. Yet we keep spoiling our own case, by talking about "agreement" which means telling the Mandatory Government that the important thing is not the iron wall, but discussions. *Empty rhetoric of this kind is dangerous.* And that is why it is not only a pleasure but a duty to discredit it and to demonstrate that it is both fantastic and dishonest.

Zionism Moral and Just

Two brief remarks:

In the first place, if anyone objects that this point of view is immoral, I answer: It is not true: either Zionism is moral and just, or it is immoral and unjust. But that is a question that we should have settled before we became Zionists. Actually we have settled that question, and in the affirmative.



We hold that Zionism is moral and just. And since it is moral and just, justice must be done, no matter whether Joseph or Simon or Ivan or Achmet agree with it or not.

There is no other morality.

Eventual Agreement

In the second place, this does not mean that there cannot be any agreement with the Palestine Arabs. What is impossible is a voluntary agreement. As long as the Arabs feel that there is the least hope of getting rid of us, they will refuse to give up this hope in return for either kind words or for bread and butter, because they are not a rabble, but a living people. And when a living people yields in matters of such a vital character it is only when there is no longer any hope of getting rid of us, because they can make no breach in the iron wall. Not till then will they drop their extremist leaders whose watchword is "Never!" And the leadership will pass to the moderate groups, who will approach us with a proposal that we should both agree to mutual concessions. Then we may expect them to discuss honestly practical questions, such as a guarantee against Arab displacement, or equal rights for Arab citizen, or Arab national integrity.

And when that happens, I am convinced that we Jews will be found ready to give them satisfactory guarantees, so that both peoples can live together in peace, like good neighbours.

But the only way to obtain such an agreement, is the iron wall, which is to say a strong power in Palestine that is not amenable to any Arab pressure. In other words, the only way to reach an agreement in the future is to abandon all idea of seeking an agreement at present.

Excerpts from the British Peel Commission Report (1937)

13. The entry of the Turkish Empire into the War excited the hopes of Jewish as well as Arab nationalism. An Allied victory, it seemed, would open the way to a Jewish return to Palestine on a far larger scale than had hitherto been regarded as practicable. The Zionist leaders, therefore, incorporated their ideas in a definite scheme to be submitted to the Allied Governments at the first favourable moment. One serious obstacle in their path the opposition of the Czarist Russian Government, was losing its force by the end of 1916; and in February, 1917, **when the British advance on Palestine was imminent, formal negotiations were opened between the Zionists and the British Government.** Similar negotiations ensued with the French and Italian Governments. **In Paris and Rome as in London the Zionist project was officially approved. The publication of this approval was delayed till at the end of October, 1917, the success of General Allenby's invasion of Palestine seemed certain. On the 2nd November the British Government published a statement of policy, afterwards known as the "Balfour Declaration", which took the form of a letter from Mr. Balfour, then Secretary Of State for Foreign Affairs, to Lord Rothschild : -**

"I have much pleasure in conveying to you on behalf of His Majesty's Government the following declaration of sympathy with Jewish Zionist aspirations, which has been submitted to and approved by the Cabinet:

'His Majesty's government view with favour the establishment in Palestine of a national home for the Jewish people, and will use their best endeavours to facilitate the achievement of this object, it being clearly understood that nothing shall be done prejudice the civil and religious rights of existing non-Jewish which may communities in Palestine, or the rights and political status enjoyed by Jews in any other country.'

I should be grateful if you would bring this declaration to the knowledge of the Zionist Federation."

15. Like the McMahon Pledge, the Balfour Declaration was not an expression of a wholly new sentiment. Just as British public opinion had sympathized before the War with the victims of the old Ottoman regime, so it had sympathized with the victims of anti-Semitic persecution. But in both cases the time and manner in which these sympathies were translated into action were determined by the exigencies of the War. In the evidence he gave before us **Mr. Lloyd George, who was Prime Minister at the time, stated that, while the Zionist cause had been widely supported in Britain and America before November, 1917, the launching of the Balfour Declaration at that time was "due to propagandist reasons"; and, he outlined the serious position in which the Allied and Associated Powers then were.**

The Roumanians had been crushed. The Russian Army was demoralized. The French Army was unable at the moment to take the offensive on a large scale. The Italians had sustained a great defeat at Caporetto. Millions of tons of British shipping had been sunk by German submarines. No American divisions were yet available in the trenches. In this critical situation it was believed that Jewish sympathy or the reverse would make a substantial difference one way or the other to the Allied cause. **In particular Jewish sympathy would confirm the support of American Jewry, and would make it more difficult for Germany to reduce her military commitments and improve her economic position on the eastern front.**

16. Those were the circumstances in which the British Government issued the Balfour Declaration.

"The Zionist leaders [Mr. Lloyd George informed us] gave us a definite promise that, if the Allies committed themselves to giving facilities for the establishment of a national home for the Jews in Palestine, they would do their best to rally Jewish sentiment and support throughout the world to the Allied cause. They kept their word."

17. To inform World Jewry of the Declaration millions of leaflets were circulated throughout the Jewish communities. They were dropped from the air on **German and Austrian towns**, and widely distributed through the Jewish belt from Poland to the Black Sea.

18. The Central Powers, meantime, had also recognized the war-value of Jewish sympathy. At the time of the Balfour Declaration the German Government was doing all it could to win the Zionist Movement over to its side; and after the Declaration it hastened, in conjunction with its Turkish allies, to formulate a rival proposition. A kind of chartered company was to be created for German Zionists. It would have a limited form of local self-government and a right of immigration into Palestine. By the end of 1917 it was known that the Turks were willing to accept a scheme on those lines; but, before the concessions were finally confirmed in Constantinople, Palestine was in General Allenby's hands.

19. The fact that the Balfour Declaration was issued in 1917 in order to enlist Jewish support for the Allies and the fact that this support was forthcoming are not sufficiently appreciated in Palestine. The Arabs do not appear to realize in the first place that the present position of the Arab world as a whole is mainly due to the great sacrifices made by the Allied and Associated Powers in the War and, secondly, that, in so far as the Balfour Declaration helped to bring about the Allies' victory, it helped to bring about the emancipation of all the Arab countries from Turkish rule. If the Turks and their German allies had won the War, it is improbable that all the Arab countries, except Palestine, would now have become or be about to become independent States.

New Palestine Party

Visit of Menachen Begin and Aims of Political Movement Discussed

TO THE EDITORS OF NEW YORK TIMES:

Among the most disturbing political phenomena of our times is the emergence in the newly created state of Israel of the "Freedom Party" (Tnuat HaHerut), a political party closely akin in its organization, methods, political philosophy and social appeal to the Nazi and Fascist parties. It was formed out of the membership and following of the former Irgun Zvai Leumi, a terrorist, right-wing, chauvinist organization in Palestine.

The current visit of Menachem Begin, leader of this party, to the United States is obviously calculated to give the impression of American support for his party in the coming Israeli elections, and to cement political ties with conservative Zionist elements in the United States. Several Americans of national repute have lent their names to welcome his visit. It is inconceivable that those who oppose fascism throughout the world, if correctly informed as to Mr. Begin's political record and perspectives, could add their names and support to the movement he represents.

Before irreparable damage is done by way of financial contributions, public manifestations in Begin's behalf, and the creation in Palestine of the impression that a large segment of America supports Fascist elements in Israel, the American public must be informed as to the record and objectives of Mr. Begin and his movement.

The public avowals of Begin's party are no guide whatever to its actual character. Today they speak of freedom, democracy and anti-imperialism, whereas until recently they openly preached the doctrine of the Fascist state. It is in its actions that the terrorist party betrays its real character; from its past actions we can judge what it may be expected to do in the future.

Attack on Arab Village

A shocking example was their behavior in the Arab village of Deir Yassin. This village, off the main roads and surrounded by Jewish lands, had taken no part in the war, and had even fought off Arab bands who wanted to use the village as their base. On April 9 (THE NEW YORK TIMES), terrorist bands attacked this peaceful village, which was not a military objective in the fighting, killed most of its inhabitants (240 men, women, and children) and kept a few of them alive to parade as captives through the streets of Jerusalem. Most of the Jewish community was horrified at the deed, and the Jewish Agency sent a telegram of apology to King Abdullah of Trans-Jordan. But the terrorists, far from being ashamed of their act, were proud of this massacre, publicized it widely, and invited all the foreign correspondents present in the country to view the heaped corpses and the general havoc at Deir Yassin.

The Deir Yassin incident exemplifies the character and actions of the Freedom Party.

Within the Jewish community they have preached an admixture of ultranationalism, religious mysticism, and racial superiority. Like other Fascist parties they have been used to break strikes, and have themselves pressed for the destruction of free trade unions. In their stead they have proposed corporate unions on the Italian Fascist model.

During the last years of sporadic anti-British violence, the IZL and Stern groups inaugurated a reign of terror in the Palestine Jewish community. Teachers were beaten up for speaking against them, adults were shot for not letting their children join them. Remarks of David Emer in opposition to Article 5 Resolution for A Ceasefire Proclamation

I would like to thank the Select Board for recognizing me. I rise in opposition to the proposed resolution for a ceasefire. I'd like to make three brief points.

First, I firmly believe that there are people of good faith on both sides of this issue. Since October 7, I have reached out to people with whom I vehemently disagree on the Israel-Hamas war. I encourage you to do so too. The challenges facing this town – hunger, the lack of affordable housing, inadequate teacher pay, among many others – are too great to set aside because of our disagreements on this resolution. We must work together and live together peacefully.

Along those lines, my second point is that we should focus on the local effects of October 7 and combatting hate generally. In May 2019, a man set fire to the Chabad House on Lake Street. That man attempted to burn children of our community alive. At my daughter's elementary school, there has been hate directed – not at her to my knowledge – but at children who are Jewish and Muslim alike. As a community, we must work to confront these incidents to make Arlington a safe and welcoming place for all. That's where our focus should be.

Third, I feel compelled to address the underlying merits of the resolution. I have family in Israel. Again, fortunately, they were not victims of the October 7 attack. Now, I don't want to be misunderstood. I have grave concerns about the manner in which Netanyahu is conducting this war. I abhor war. As a college student, I went to D.C. to protest the unjust Iraq war. Today, with a world on fire, I pray that our leaders have the fortitude to prevent a regional or even world war.

That being said, a ceasefire is not a solution that will keep my family in Israel safe. This war will end. It will end when Hamas unconditionally surrenders. Hamas's indiscriminate killing of children, sexual violence, and abduction of civilian hostages, means that Hamas cannot remain in power. Hamas kidnapped babies. Its eradication is an issue of basic morality. I urge the Select Board to oppose this resolution.

Dear Select Board,

I am a resident of Arlington and am writing to express my support for the proclamation in support of an immediate and permanent ceasefire in Gaza. Please attach this to the agenda as public comments.

One of the things that resonated with me in an [article](#) I read about the Medford ceasefire resolution was how local statements like these are a way to amplify public opinion and the voices of local residents who feel ignored at federal levels of the government. Massachusetts towns such as Somerville, Cambridge, Medford, Melrose, Northampton, and Amherst have already passed ceasefire resolutions. And support for a ceasefire is shared widely. The latest Gallup polls suggest that nearly [75%](#) of all US adults disapprove of what is happening in Israel currently. I am Muslim American, and I have been buoyed by statements from people of conscience from all backgrounds-- over [1000 Black Pastors](#), over [1000 Rabbis](#), [U.S. Churches](#) via the National Council of Churches, [church leadership worldwide](#), [the Pope](#) (who has reiterated his call [twice](#)), and so many more. This is because the current situation in Gaza has reached records we are all horrified by-- the largest cohort of [pediatric amputees](#) in history, [more children killed](#) in 4 months in Gaza than all over the world over four years, more healthcare workers and aid workers kidnapped and killed than all world's conflicts in previous years, a [larger carbon footprint and environmental impact](#) than more than 20 of the world's most climate-vulnerable nations in just the first 60 days of bombings -- and all these statistics have already become underestimates given that we are now 200 days in and counting, with violence continuing unabated. That billions of our tax dollars are used to fund the weapons used on innocent civilians make this all the more important for us to take an unequivocal stance for peace.

I also want to share an experience I had attending a rally calling for a ceasefire in downtown Boston, as one example of how I've been impacted and why this is personally important as an Arlington resident. Shortly after the rally had started, a woman in the crowd had a seizure, and, as a neurologist, I took care of her until the paramedics arrived. As the crowd had marched far away from us, I decided to come home. While I was waiting for my Lyft back to Arlington, two women noticed I was holding a sign that said "Healthcare Worker for Gaza," and they began to berate me. They first said: "Just go to Gaza" and "Why don't you leave America then and go to Gaza." I initially responded, "I would love to go there and help people who are dying." My first inclination as a healthcare worker is always to jump in to help, and this was before 400+ attacks on hospitals in Gaza making delivering healthcare there nearly impossible. But then one smirked and said and repeated: "yes, go over there and see what they will do to you. See what they will do to you." Her insinuation was clear: as a Muslim woman with a headscarf, I would be shot and killed.

This incident was steeped in the logic of collective guilt, which has unfortunately been used to justify the horrific current reality in Gaza and statistics I included in my email above. But there can be no justification for this degree of indiscriminate killing and violence, like newborn Palestinian babies being left by Israeli soldiers to [die and decompose](#) in their hospital beds with milk bottles and diapers next to them. It is absolutely within our power to say that people who look like me and children who look like my children do not deserve to die simply because they are guilty by association.

I hope you will support this proclamation as a message of hope and peace for residents of Arlington. I will end with the words of Michelle Alexander from this poignant [interview](#): "All of us have a conscience that whispers to us, sometimes in the dark. The mandates of conscience that arise within each of us arise not out of loyalty to abstract principles or doctrines, but from a place of deep knowing, a deep knowing that we owe something to each other as human beings, that we belong to each other, and that our freedom and liberation depends on one another."

I have lived in East Arlington for over 25 years. I write not only as a long time resident but also as a deeply concerned citizen of the planet.

Thinking globally, we know we are in a climate crisis and as we try to tackle the urgency of that crisis, I am moved to raise my voice locally for peace and against the conflict in Israel and Palestine. The devastation in Gaza caused by relentless bombing and bulldozing is causing a humanitarian crisis that I am not willing to ignore. Every day, innocent people are dying in hundreds, while their cultural, educational and healthcare institutions are turned to rubble. My name is Hina Jolin, I am a long-time Muslim resident of Arlington, a town I chose to raise my family because of its progressive, diverse, and inclusive nature. I am writing to you today to implore the Select Board to adopt a proclamation in favor of an immediate and permanent ceasefire in Palestine, the release of all hostages, including those held illegally in Israeli prisons, the immediate provision of lifesaving humanitarian aid to Palestinians, and a diplomatic resolution for Palestinians and Israelis.

Arlington has a growing Muslim community, with a highly diverse and educated group of residents. We have participated and contributed to the cultural and economic strength of this town; yet we are regularly overlooked, or worse, subjected to acts of hate. Our students are being harassed and discriminated against at all levels and the Muslim workforce is being silenced for voicing our fears. Support from our elected officials has never been more essential. I am asking you to reflect on the immense power you have to change course at this very moment. You have the extraordinary privilege to influence cities and towns across the Commonwealth and lead by example.

We all witnessed the horror of October 7th, and it is right to condemn that violence. However, in this moment, 7 months later, silence equates to unconditional support for Israel's disproportionate and indiscriminate response by elected officials across the US political spectrum, which has resulted in our nation's tacit responsibility for the genocide happen right now. Dear Arlington Select Board,

My name is Nathan Nesbitt. I grew up in central Massachusetts, lived in Medford and Cambridge during my PhD at Boston College and I now live in Arlington with my wife and toddler while working in Somerville on green tech to address climate change.

I ask that the board vote on a proclamation/statement calling for an immediate and permanent ceasefire in Gaza.

I have been deeply saddened to read reports of ongoing killing and starvation in Gaza, which follow explicit statements from Israel's highest elected and appointed leaders of their intention to prioritize damage and to block food, water, electricity, and fuel.

I have been frustrated that family members and my workplace have discouraged conversation on the topic.

Silence enables the status quo.

I have lost trust in my federal government to follow its own laws that protect civilian lives.

This makes me worry for the lives of myself and my family members (some of which are muslim and not white). This is because the US federal government has used tax dollars from me and Arlington to send offensive weapons to Israel, often without congressional approval, and in obvious defiance of our own humanitarian laws. Specifically, after the Biden administration had for months repeatedly criticized Israel for blocking humanitarian aid to Gaza, it then certified that Israel does not block aid, allowing additional bombs to be shipped to Israel in recent weeks.

Similarly, our federal government has repeatedly complained of too high civilian killings in Gaza, but then said South Africa's case at the ICJ accusing Israel of genocide was baseless. It has blocked UN action on ending genocide. This creates dangerous precedents of putting politics above human lives.

This status quo of one-sided ongoing large scale killing and starving in Gaza in a one-sided non-proportional genocide I find very troubling, particularly with US funding and arming of one side, Israel. Israel cannot use ongoing famine, with hundreds dying daily from starvation, as a bargaining chip in negotiations for hostage release.

The onesidedness of the conflict is why any statement from AHRC must center the plight of Gazans experiencing genocide, not legitimize Israel's position by saying both sides are at fault.

Our federal government has failed us in following its own human rights laws. **Thus, the town of Arlington has an obligation to speak up for human rights.** This is why statements on such international politics are within the purview of the AHRC and Select Board, consistent with their historic precedent of making past statements.

As an impacted member of the community, other community members would make me feel more welcome, safe and valued in Arlington by standing against silence. By speaking out against the status quo of famine in Gaza and illegal arms shipments from the USA.

The town of Arlington itself can take action to make me feel more welcome, safe and valued in Arlington by making a statement calling for an immediate and permanent ceasefire.

My name is Naila Al Hasan. I am writing to you to ask that you vote for a permanent ceasefire in Gaza and the West Bank. Please attach my letter to the agenda as public comments.

After 7 months of ethnic cleansing that has killed over 41,000 Palestinians and the near-complete destruction of Gaza, a permanent ceasefire resolution is not only the bare minimum, it is time to end US financial and moral complicity, and sanction Israel for war crimes. As such, my family are additionally choosing to engage in Genocide Tax Resistance this tax season as I explain below.

My family moved to Arlington about six months ago primarily because of its family friendly focus. I am a stay-at-home parent to a toddler as well as 6.5 months pregnant.

In fact, I've been pregnant almost exactly the same number of days as the Israeli aggression, now officially a genocide, on the Palestinian people. The horrifying footage coming out of Gaza is distressing and traumatizing to bear witness to. We cannot continue to stand by and whitewash the suffering of the Palestinian people. A permanent ceasefire is critical to saving precious human lives. As world citizens and taxpayers whose taxes are unjustly funding the Israeli genocide of the Palestinian people, it is our responsibility and moral duty to do the right thing by enabling an end to this carnage.

Earlier this month, on April 5th, 2024, day 182, it was Palestinian Children's Day. Here are some stats that marked the occasion:

- 1) Israel has killed 14,000+ children in Gaza and 117 in the West Bank since Oct. 7th. 31 of the Gazan children were killed by starvation while 50,000+ are actively malnourished
- 2) 200 children are held captive by Israel
- 3) 17,000+ are unaccompanied or separated by immediate family
- 4) More than 10 children on average have lost one or both of their legs every day in Gaza since October 7, with many amputations performed without anesthesia [1]
- 5) 'Wounded child, no surviving family' is an official term for injured children with no parents to care for them [2]
- 6) As of Dec. 4th, 2023, nearly 25,000 Palestinian children in Gaza have become orphans [3]

These are just SOME of the horrific stats reported by reputable agencies.

One video that has stuck with me is of 5 year young Faisal recounting the moment his mother was executed in front of him in cold blood.

"They shot her in her stomach. She was pregnant"

In what world is this acceptable???

Bearing witness to a new level of horror every day of the past 198 days has left me in a continuous state of dysregulation and trauma, I already worry I am passing on significant trauma to the child I am carrying.

As a nation, we have funded Israel with \$3.8 billion USD, no-strings-attached every year since 2017. Massachusetts and Arlington have sent \$129,975,320 and \$706,408, respectively, taxpayer monies for weapons [4].

In Arlington, this aid could instead be used for:

- 83 households with public housing for a year
- 245 children receiving free or low-cost healthcare
- 7 elementary school teachers
- 2,011 households with solar electricity produced for a year
- 18 students with their loan debt canceled

For many years, I've lobbied US representatives, without success, to condition this aid as Israel has used this funding to implicate, detain, and imprison children. House bills were introduced by Congresswoman Betty McCollum that never saw a companion bill in the senate [5].

In light of these facts, my family is choosing this year to divest our taxes from the state of Massachusetts as well as our home town of Arlington so long as they continue to invest taxpayer monies, and therefore, make us personally complicit in the Israeli genocide of Palestinians.

My name is Carissa Englert, and I am writing to request that the AHRC propose and vote on a proclamation calling for an immediate and permanent ceasefire in Gaza. I also propose that when this proclamation is passed by the AHRC, it be sent to the Arlington Select Board for a vote.

On top of these appeals to AHRC, in a larger sense we are calling for Congress and the Biden Administration to:

1. Demand an immediate and permanent ceasefire
2. Rush humanitarian aid and work to reinstate UNWRA
3. Stop funding military aid to Israel
4. Hold the Israeli government accountable to international law

As an new Arlington resident, I feel very strongly about the fact that I live in a town which has not yet taken the steps to address the ongoing genocide of the Palestinian people. As someone who works in education, it disgusts and infuriates me to know that over twice the equivalent of our student population - at least [13,000 innocent children](#) - have been murdered in Gaza since October.

It is our responsibility as people of conscience to demand an end to the relentless violence that has been destroying all life in Gaza. At this moment, more than [32,000 Palestinians](#) have been murdered by the Israeli Forces since October. Knowing that this would not have happened without the unwavering support from the United States government, and knowing that our [billions of tax dollars](#) continue to fund the guns and bombs used on innocent civilians, is beyond sickening for anyone who has been paying attention.

The violence in Gaza continues to be felt deeply here in Arlington. My name is Layla Khayr- I'm an Arlington resident, Arab American, a visible headscarf wearing Muslim woman, a social worker, an educator, and a community member.

I ask that you vote in favor of a ceasefire resolution.

Calling for a ceasefire is the most important first step to stopping the relentless massacres in Palestine, and Gaza specifically. Because this genocide is funded by the US - our tax dollars payoff weapons and bombs- it's our responsibility to take a stand.

In Arlington, it is estimated that over 700,000 dollars of taxpayer money has gone to Israel's weapons. As a social worker, I am painfully aware of the ways in which historically oppressed communities are in need of resources- resources that could be funded with these same tax dollars.

The ongoing genocide in Gaza is racist, settler colonialist, and orientalist.

These ideologies have implications abroad and here in Arlington. These are racist ideologies, rooted in white supremacy. This is Anti- Arab and Anti- Muslim racism. Dear Arlington Select Board,

I write in regard to the Ceasefire Resolution that concerned residents of Arlington have brought before the Board. As a long time Arlington resident and peace activist during the long years of forever wars, I recall bringing a similar resolution to the Select Board and to Town Meeting to call for an end to the war on Iraq, particularly with regard to bringing the Massachusetts National Guard home.

At that time the Board voted No Action and one prominent Board member was vocal about how she could not "stomach" a resolution that addressed the foreign policy our taxes pay for. However, later it was found that illegal underage drinking was taking place in her home and she evidently did not have an issue "stomaching" that.

It is estimated that between 280,771-315,190 Iraqis were killed by direct violence as a result of the invasion and occupation. According to the Massachusetts Fallen Heroes Memorial 301 Service Members were killed in the Global War on Terrorism.

It seems clear to me that these deaths have been considered worthwhile in general by society, despite the fact that no wars were won, that the violence was wanton and cruel, continuing for many years. In 2011 the U.S. departed Iraq due to the "Status of Forces Agreement" passed by the Iraqi Parliament. A pointless war, costing trillions of tax dollars, as well as the lives lost.

It is two decades later, a new series of conflicts has erupted in the Middle East. More than 33,000 people, mainly women and children in Gaza have been killed by Israeli and U.S. bombs since the brutal incursion by Hamas militants on October 7, 2023 into Israel. The conflicts are spiraling out of control and could easily lead not only to a wider war, but one in which nuclear powers (Israel is a nuclear power) begin to reach for these planet-destroying weapons.

Simply put, Planet Earth is facing a serious climate crisis, one that, to be solved, must mean that all wars and commerce of militarism (which uses tremendous amounts of oil) are ended. Yesterday would not be soon enough.

As ordinary people, we are placed in a difficult position, with many conflicting wishes and priorities. At the very least, vision and courage are needed to assess the whole picture, to understand that while there is always antisemitism, as there is always racism, to absolve a nation-state that is openly - even referring to human beings in Gaza as vermin - massacring a captive population in a revenge war is morally repugnant and restraints should be imposed by the global community of which we are a small part.

I hope that the Select Board of 2024 will do better than the Board of twenty years ago. It is good to learn from history, to not sidestep issues that cause discomfort and to take action out of a real concern for people who are being consigned to the dustbin of history before our eyes.

I am writing, as a Jewish Arlington resident, to urge you to **support** a Town proclamation calling for an immediate and permanent ceasefire in Gaza. This is one of the most urgent issues of our time, and I am looking to *you* to make a difference in this debate for our community.

As an ethics professor and as a scholar who has studied genocides in Europe and in other contexts around the world, it is my opinion that Israel's policy towards the Palestinians is genocidal. In saying this, I am affirming the opinion of hundreds of other scholars in Holocaust and genocide studies, and international human rights law. The term "genocide" was developed in 1944 by the Polish-Jewish jurist Raphael Lemkin, to describe total war waged not against states or their armies, but against a civilian population. The aim of genocide is not necessarily to kill every single member of a victimized group, but to erase its collective identity through physical, psychological, and cultural destruction. I believe that this is what is occurring today in Gaza, and with the full participation of the United States government.

I am Japanese-American on my father's side and Jewish on my mother's. My maternal grandfather founded a Jewish temple in Connecticut, and I raised my son with a secular Jewish education at the Workmen's Circle (at one time, the largest Jewish organization in the US). In my scholarship and teaching, I draw on the work of such Jewish philosophers as Emmanuel Levinas and Martin Buber, as well as Jewish writers like Primo Levi and Isaac Bashevis Singer and filmmakers like Claude Lanzmann (director of *Shoah*, about the Holocaust). Despite all this, apologists for Israel's ongoing crimes in Gaza would characterize my criticisms of the Israeli state as "antisemitic." Here is a link to a clarifying debate in England several years ago about the absurd proposition that "Anti-Zionism = Anti-Semitism": https://www.youtube.com/watch?v=K1VTt_THL4A&t=720s.

I say all this by way of urging you not to be intimidated by those who conflate principled criticism of Israel and urgent defense of human rights with "antisemitism." To conflate critique of the Israeli state with "antisemitism" is dangerous for three reasons. First, because it silences people with legitimate humanitarian concerns about the vulnerability and safety of the millions of people at risk of imminent death in Gaza. Second, because it sets a bad precedent for our future ability to name state crimes, including the most serious of those crimes, genocide. Third, because it endangers Jews in the diaspora, by tarring them morally with the unjust policies of a state over which they have no control. Ironically, Zionist American Jews have a special responsibility to distance themselves from the heinous policies of the state they profess to love, because Judaism is an epic *moral* tradition, and Jewish chauvinism should have no place in it.

I condemn the indiscriminate nature of the October 7 attacks by Hamas on innocent Israeli civilians, as we all must. However, that attack (which incidentally killed half as many civilians as Israel killed during its 50-day war on Gazans in 2014) can in no way excuse Israel's actions since then, which are without question designed to destroy the Palestinians *as a people*. Since Oct. 7, Israel has engaged in the following war crimes and crimes against humanity:

- Starvation as a weapon of war--withholding of water, food, medicine, and fuel to 2.3 million people, half of them children.
- Indiscriminate mass bombing of densely populated urban neighborhoods and apartment complexes, including with 2000-pound bombs.
- Ethnic cleansing.
- Forced displacement of a civilian population.
- Killing of civilians in designated "safe zones."
- Use of white phosphorous against civilian targets.
- Bulldozing of displaced refugees in their tents.
- Bulldozing and desecration of cemeteries.
- Use of AI technology to intentionally kill entire families in their homes.
- Destruction of hospitals, medical clinics, ambulances, and physicians.
- Assassinations of journalists and their families.
- Destruction of universities and schools in Gaza.
- Sniping of unarmed civilians gathering food, of children, of nuns, of doctors.
- Summary executions of unarmed civilians waving white flags.

This is not a complete list. These and other crimes have been documented by dozens of organizations, including:

- The UN Office of Human Rights
- UNICEF
- Doctors without Borders
- Save the Children
- CARE
- Oxfam
- The Norwegian Refugee Center
- Amnesty International
- Human Rights Watch

Yet, tragically and outrageously, the Biden administration has continued to back Israel's crimes against humanity by rushing ever more ordnance and other materiel to Netanyahu, all the while cynically professing its "concern" about the "suffering" in Gaza. The US also continues to work closely with the IDF and Israeli intelligence to commit these atrocities. Despite the fact that the vast majority of Americans oppose US support for Israel's war on Gazan civilians, however, President Biden has remained immovable.

Hence my letter: I urgently appeal to the Select Board to support an Arlington Town resolution to join the hundreds of other communities across the United States in issuing an unequivocal statement condemning Israel's policies and calling for an immediate and unconditional ceasefire in Gaza, including the immediate, full restoration of water, food, medicine, and fuel to the territory. There are times when we must all step up and make our voices heard in the face of an absolute evil--and this is one of those times.

The purpose of this memorandum is to update the Select Board on the new Arlington Community Electricity (ACE) program contract, including optional products and rates.

Summary of Select Board Decisions on ACE Contract

In its March 18, 2024, meeting, the Select Board discussed the ACE contract renewal and the level of renewable energy in the ACE default product.¹ The Select Board authorized the Town Manager to target a percentage of renewable energy in the ACE default product of no less than 60% Class I² renewable energy in addition to the renewable energy required by the state Renewable Portfolio Standard (RPS),³ striving for a percentage equal to 100% total Class I renewable energy including the RPS requirements. The Select Board also provided guidance to eliminate the RPS +50% optional product and retain the RPS +100% product, provided that the language marketing the ACE program sufficiently clarifies the renewable energy content in the RPS +100% optional product.

Key Contract Components and Pricing

The Town has secured a new, three-year supply contract for November 2024–December 2027, with a default product containing 100% total Class I renewable energy, including the RPS requirement. Because the RPS will increase each year of the contract, to maintain the 100% renewable energy level, the Town will add voluntary MA Class I renewable energy equal to 76% in 2024, 73% in 2025, 70% in 2026, and 67% in 2027. The Town will contract with a new supplier, Direct Energy Services, LLC. The Town has also eliminated the RPS +50% optional product and retained the RPS +100% product.

With this new contract, the Town will be the first community in the state to offer a 100% total Class I renewable energy default product. The Town has also achieved this priority goal from its Net Zero Action Plan five years earlier than planned.

As expected, the cost of the ACE Basic product has decreased alongside electricity prices across the market. For all ACE products, the following table displays updated rates and savings compared to the equivalent products under the current ACE contract. The table does not display the Eversource Basic Service rate for comparative purposes, as rates beyond July 2024 are unknown. All information in the table below represents only the supply portion of the electricity bill.

ACE Product Rates and Renewable Energy Content for 2024-2027 Contract

Product	Rate (\$/kWh)	Rate Reduction Compared to Current ACE Contract	Estimated Annual Savings for Average Residential User Compared to Current Contract Rates*
ACE Basic	\$0.13380	2.71 ¢/kWh	\$149
ACE Local Green (Default)	\$0.16230	0.97 ¢/kWh	\$53
ACE Local Greenest	\$0.17430	2.36 ¢/kWh	\$129

Notes: *Based on the average consumption of 5,502 kWh/ per regular residential (R-1) household. Total costs of electricity for R-2 and R-3 low-income customers are lower than R-1 customers.

Next Steps

In the fall (likely September), the Town will mail all ACE participants a renewal notification detailing the new contract program rates and supplier. Participants will be informed of the ACE product in which they are currently enrolled and will remain enrolled without further action, except for RPS +50% product participants. RPS +50% product participants will be notified that this product will be discontinued and that they will be enrolled in the default product without further action. Participants will also be provided at this time with information regarding how to switch to a different ACE product or opt out of the program entirely. The Town plans to rename the RPS +100% opt up product to ensure participants understand the difference between this product and the default product.
