#### **OBJECTIVE**

Experienced and licensed Nurse Practitioner with fourteen years of experience working with geriatric patients in the home, assisted living, and long-term care setting. Seeking a clinical role to continue to serve and care for elderly patients and their families. Thoughtful management of complex needs. Compassionate and respectful communication with patients, families, and the interdisciplinary team caring for them.

Nurse Practitioner June 2014 - July 2020

- Served the complex needs of frail elders at home in the nurse practitioner-run Intensive Home Based program at Atrius Health/Harvard Vanguard Medical Associates.
- Managed acute and chronic health conditions such as congestive heart failure, COPD, diabetes, pneumonia, and falls.
- Provided stability and close monitoring for a panel of patients during transitions in care, ie hospital to home.
- Discussed goals of care and worked with patients, families, and interdisciplinary team members to meet their goals and expectations.
