Open Meeting

Ms. Morgan opened the meeting at 6:30 p.m. and read the governor's orders and confirmed the attendance of the following: Liz Exton, Present, Len Kardon Present, Paul Schlichtman Present, Dr. Kirsi Allison-Ampe Present, Jeff Thielman Present, Bill Hayner Present and Jane Morgan Present.

Confirmed attendance of Kathleen Bodie, Ed.D., Roderick MacNeal, Ed.D., Rob Spiegel, Michael Mason, Alison Elmer, Karen Fitzgerald. Principals present tonight are Matthew Janger Ed.D. Sir Ferranti, AEA Representative, Cindy Sheridan-Curran and Dr. Susan Franchi.

Public Comment

Mette Aamodt, spoke on her concern that the School Committ is hearing the results from the November 2020 parent fall survey two months later. She feels the presentation put a better light on the results that it is and said all questions are not included in the report. Ms. Aamodt would like a plan for full in-person for this school year.

Mr. Grose, parent of 1st grader is in favor for in-person learning when the vaccine is available with the proper social distance. He said the school committee members could contact him to discuss the plans being considered.

FY 21-22 School year calendar

Dr. Bodie presented 2021-2022 APS School Calendar for a first read tonight and said the calendar remains the same as previous school vacation weeks. Ms. Morgan recommends that the committee members vote to start school after Labor Day so families can plan ahead. She wants to vote the first day of school which will be held on Wednesday, September 8, 2021. The committee members spoke in regards that the first day of school is held on Wednesday, September 8th, which would be the second day of Rosh Hasahana After they discussed this, it was asked if the students could be remote and have it as a regular remote school day. Dr. Bodie said the Commissioner was limiting remote days this year and no remote days next year unless there is a DESE policy next year. The members said it is to our benefit to close on certain holidays and since many of the staff observe just one day on Rosh Hashanah, in years past we only oberve the first day.

The School Committee meeting schedule was discussed, and it was suggested to change the dates of some of those meetings. Dr. Bodie discussed Kindergarten screening and said it has yet to be decided if that would happen this June or September, 2021. The committee wanted the start date of school to be clear for families tonight. The committee then discussed moving the first day of school to Thursday, September 9, but are also concerned with day care for many families with having so many days off the first week of school. The members made a suggestion

to setup a committee to do the research on how many students and staff will not attend on Wednesay, September 8th and bring forth a recommendation to the communitie in two weeks. One members said since the research had been done in the past and it was recommended to give one day to Rosh Hashanah, Yom Kippur and Good Friday.

On a **motion** by Mr. Thielman, seconded by Mr. Kardon, it was voted to open schools on Wednesday, September 8, 2021 and planning on full in-person learning for all learners.
