NOTIFICATION: Chestnut Street Corridor Pedestrian Safety Improvements; Public Listening Session on Tuesday March 30

Dear Resident or Business Owner,

The Town of Arlington Department of Planning and Community Development and the Transportation Advisory Committee are hosting a virtual public listening session to discuss safety improvements along the Chestnut Street corridor, and specifically pedestrian safety around the crosswalk at Chestnut Terrace. This meeting will take place on Tuesday, March 30, at 7 PM. This meeting will be conducted remotely due to the ongoing state of emergency caused by the COVID-19 pandemic. This crosswalk was the site of a fatal collision when a driver struck a pedestrian on December 31, 2019. The Town would like to hear community ideas about this corridor and feedback on potential short- and long-term improvement options for Chestnut Street. These community recommendations will inform final proposals that will be submitted to the Select Board for review and approval. The goals of the listening session are to improve the pedestrian safety in this area; reduce speed of vehicles through the corridor; and increase the safety and comfort of vulnerable road users, specifically people walking and bicycling. After collecting community feedback, the Transportation Advisory Committee expects to determine final recommendations at their May or June meeting that will be sent to the Select Board with short-term improvements to be implemented as soon as possible.

The Town is pursuing pedestrian safety improvements along the Chestnut Street corridor in response to a pedestrian fatality at the intersection of Chestnut Street and Chestnut Terrace on December 31, 2019. This survey is designed to complement the virtual public listening session scheduled for Tuesday, March 30 at 7:00 pm, and can be taken before or after the meeting. The survey presents a range of short-term, medium-term, and long-term concepts for improving safety in this area. The Town is soliciting feedback from the community on these concepts. Community comments and suggestions will inform the proposals that the Transportation Advisory Committee (TAC) develops and submits to the Select Board for review and approval.

The goal is to develop concepts that address the following:

- Improve pedestrian safety
- Improve bicycle safety
- Reduce vehicle speeds through the corridor

The Department of Planning and Community Development (DPCD) and TAC expect to present final recommendations to the Select Board in May or June, with a goal of implementing short-term improvements as soon as possible.

Short-Term Improvements

Below are a series of options for changes to Chestnut Street, and particularly the pedestrian crossing near Chestnut Terrace, about which we would like to get your feedback. These improvements, with approval by the Select Board, can feasibly be installed and operational by the end of 2021.



Which of these short-term options would help improve pedestrian and bicyclist safety at Chestnut Street and Chestnut Terrace? Option numbers below correspond to the locations called out in the map above. *(Select all that apply.)*

- 1 Repair sidewalk spanning the Russell Common Lot driveway; install detectable panels on both sides of driveway
- Install a temporary bumpout at the Chestnut Terrace crosswalk and monitor improvements to safety
- Install a temporary pedestrian island mid-street at the Chestnut Terrace crosswalk and monitor improvements to safety
- Install additional crosswalk warning signs throughout the Chestnut Street corridor
- 5 Remove the crosswalk at Chestnut Terrace and re-route pedestrians to crosswalks at Medford St or Mystic St
