#### NARRATIVE

On Monday, January 02, 2023, at approximately 1215 hours, this Officer M. Foley, while assigned to Sector 4&6, Car 354, responded to 103 Rhinecliff St., to investigate a dog bite.

Upon arrival this Officer spoke to Leslie Oringer, who stated as she walked her two dogs by 126Rhinecliff St., two large Rottweiler's pushed open the side door, ran towards her and began attacking her dogs. Oringer was able to show this Officer several large laceration/Bite marks on her dog Rocky,

who is a 8yo Wheaton/Poodle mix. Oringer also showed this Officer several areas around her dog Tyson's neck area which appeared to be bitten but due to his extremely long coat and agitated state we could not see any wounds at that time. Tyson is a 3yo Doodle mix. Oringer stated she was responding the emergency Vet located in Fresh Pond and would contact this Officer with any further report on injuries. Oringer was provided with the Rabies information on the other two involved dogs.

This Officer then made contact with Jenista Bermudez, who stated that her two Rottweiler's Mia (1y0) and Titan (2y0) pushed open the side door and began fighting with two dogs in the street. Bemudez stated that Mia was up to date on her rabies (tag # 220173) which she received at Vetco in Medford. Bermudez stated Titan was also up to date on his rabies (tag #0529) which he received at Merlin in Allston. Bermudez was advised the BOH would follow up with her tomorrow and to keep the dogs quarantined until then.
