Food Link Inc., a local non-profit agency that rescues fresh food and alleviates hunger, is seeking separate and/or combined competitive bids for the following scope packages for their new headquarters at 108 Summer Street, Arlington, MA 02474. The project is funded by the U.S. Department of Housing and Urban Development through a Community Development Block Grant administered by the Town of Arlington.

\* Furnish and delivery of 22 kW natural gas-fired backup generator that is compatible with already-installed Generac automatic transfer switch (ATS.)

\* Generator start-up and test, according to manufacturer's specifications, after installation is complete. Test the functionality of the ATS.

\* Construct and install generator support structure (pressure-treated 4 x 4") that is lagged to the EPDM-sheathed deck and is properly flashed. *Architectural sketch available.* 

\* Generator is lifted approximately 15 ft from the parking lot, and then placed atop support structure, which will require a horizontal reach of approximately 10 feet. Existing conditions *photos available*.

\* Backup generator final electrical wiring (building is already wired, including Generac transfer switch, to the generator location.) *Existing conditions photos available.* 

\* Backup generator final gas piping (building already has internal gas piping to the generator location.) *Existing conditions photos available.*
