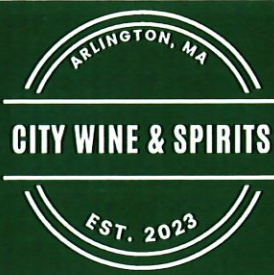

Alcohol Licenses and Regulations**

A. General Statement of Policy.

The Town of Arlington is home to a wide array of retail establishments. As the local licensing authority for all sales of alcoholic beverages in the Town of Arlington, the Select Board ("Board") wishes to support the existing business climate and to stimulate its further growth through the issuance of Package Store Licenses as appropriate. The Board also intends that all service and consumption of alcohol in the Town of Arlington be done responsibly and in conformance with all legal requirements. In service of these goals, licenses will be issued under these Policies, Rules, and Regulations only to holders of package store licenses with the consistent expectation that licensees will conduct their establishments to the highest standards.

The Board intends that the issuance of package store licenses will contribute to the Town's development in the following respects:

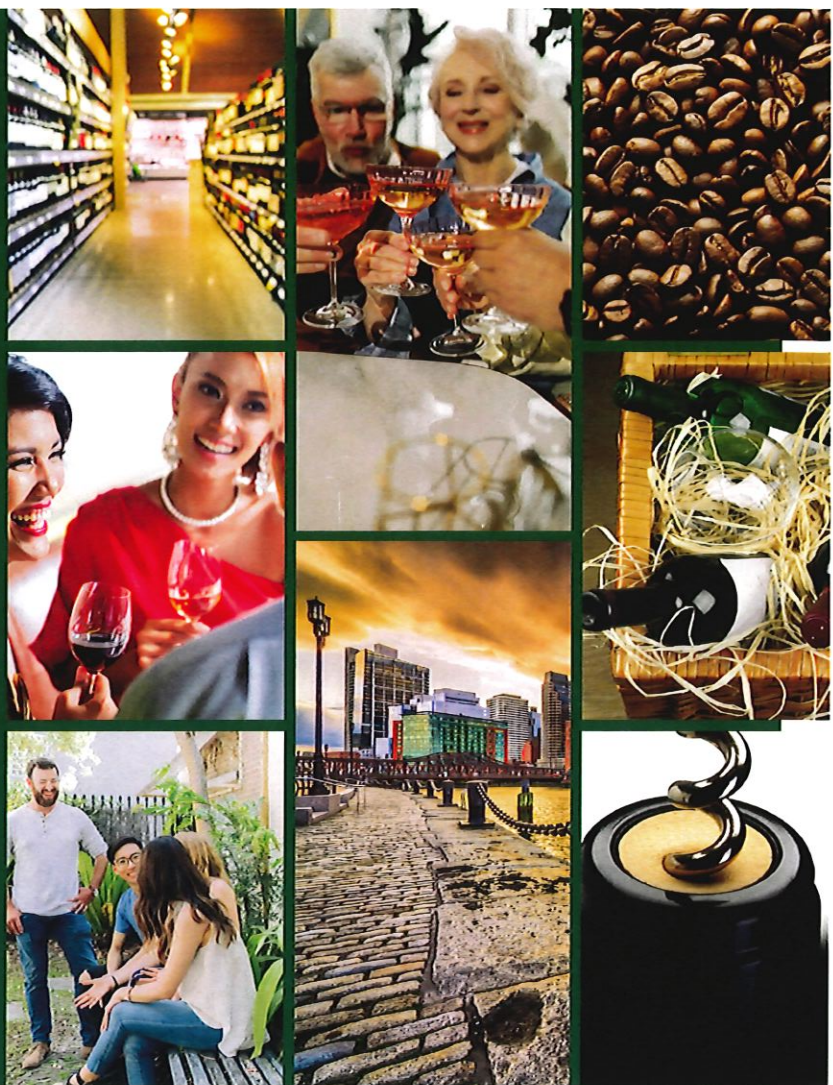

1. Bring to the Town quality shops that provide retail alcohol products in attractive surroundings	Our mission is to be a good neighbor and provide the community with a high quality store to purchase adult beverages in a safe and professional environment. We will provide a unique experience with wine tastings, pairings and cocktail suggestions all supported by quality wine, artisanal spirits, and craft beer selections.
2. Provide convenient and attractive parking options	Along with many other local businesses including restaurants, churches, funeral homes, hair salons, cinemas, etc. we acknowledge that there is a need for more convenient parking. Our hours of operation compared to neighboring businesses intend to reduce parking congestion.
3. Improve the variety of shops in Arlington	City Wine & Spirits will provide a unique retail shop with a curated artisanal selection of adult beverages, an online presence, wine tastings, party consultation, corporate gifting, and a selection of non-alcoholic beverages.

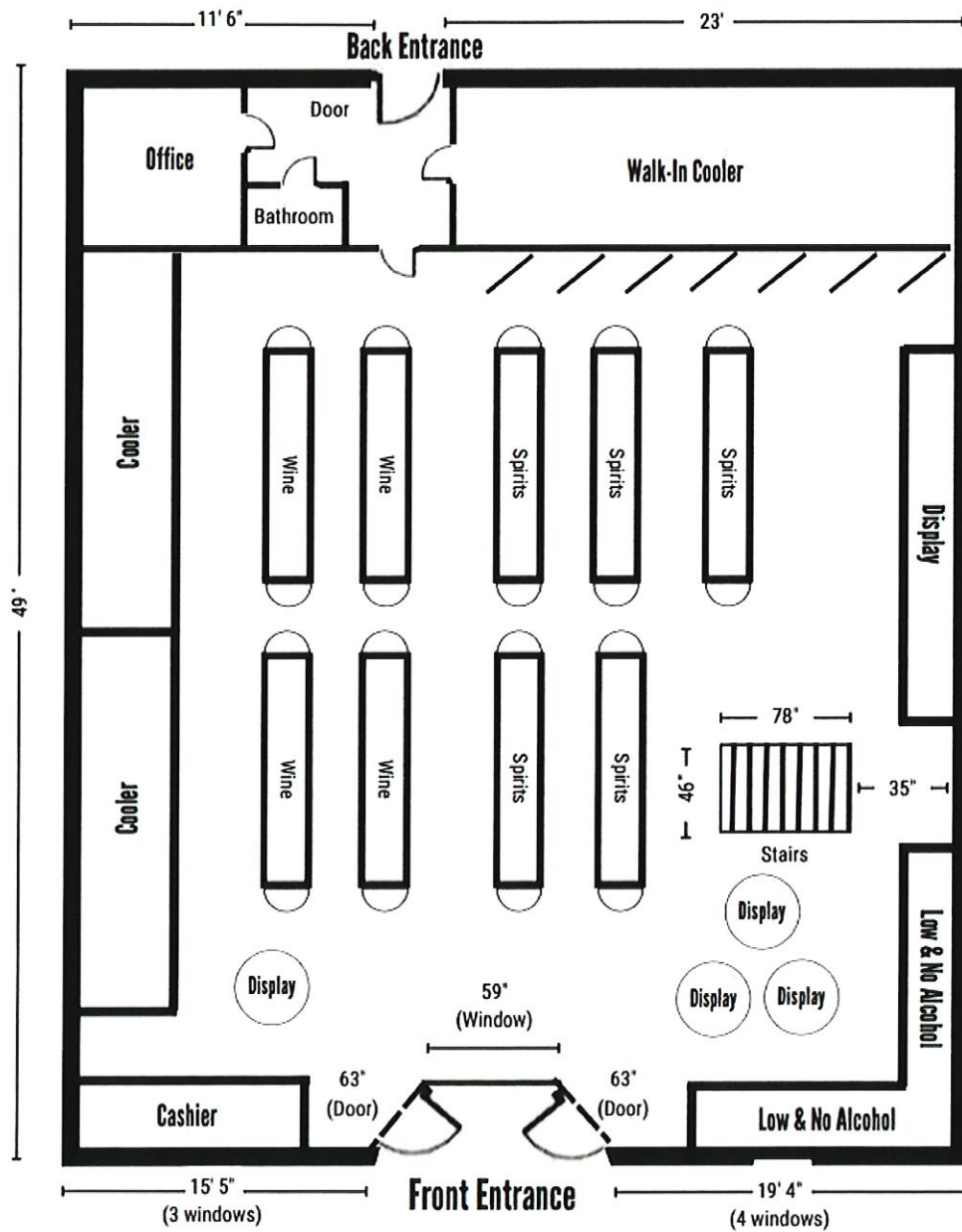
The History Behind 234 Massachusetts Avenue

The Cronin family has a long and sentimental history with the town of Arlington and their family-owned property at 234 Massachusetts Avenue. Since the 1970's, they have dedicated their space to support small businesses that add value to the neighborhood with fundamental retail stores. The location made its imprint in the community starting out as a grocery store and then a long-standing dry cleaner. Unfortunately, with the economic struggle caused by the pandemic as well as the decrease in demand for dry cleaning services, Rainbow Cleaners was forced to permanently close its doors. Coming from a family of small business owners, Lisa Cronin dedicated her time to working closely with her tenants during the pandemic to help keep them afloat.

234 Massachusetts Avenue has been vacant for almost two years, and Lisa has been working diligently alongside her three children and a broker, to find a fundamental business that will add value to the community, just like the grocery store and dry cleaners once did. Nilkant 232, inc is making a large investment in order to make this project successful. We are committed to full compliance with all local and state regulations and look forward to working with the community to establish a safe, friendly, community store without negative impacts on the neighborhood. We value our relationship with the neighborhood and the community, and we value our liquor license. Below find a list of our major compliance initiatives. As always, we will seek to modify and improve our program as new technology and best practices are developed and as we get input from local stakeholders.

1. We will card all customers regardless of age
2. We will card everyone in a group even if just one person is buying alcohol
3. We will not sell candy in order to discourage underage customers
4. We will not have a waiting area or outdoor gathering area in order to discourage loitering
5. All managers, stock personnel, and cashiers will have TIPS (or other approved) training
6. We will have a cloud-based digital cash register/inventory system to prevent theft by customers or staff
7. We will have a state-of-the-art ID scanner system
8. We will hire a mystery shopper service to test our ID and compliance practices
9. We will have video monitoring and we will share those videos with the police department as requested
10. Our focus will be on artisanal spirits, craft beer, quality wines, and specialty coffee beans to engage customers who prefer quality over quantity
11. We will not sell kegs
12. We will coordinate with local police to prevent issues and share best practices
13. We will always have responsible, well-trained, friendly staff on-site to serve our customers
