#### Building

- · All building changes need permits.
- All sign changes need approval and a sign permit.
- Window signs cannot exceed 25% of the window.
- Certificate of Occupancy is needed \$100 fee.
- The Director of Inspectional Services has no objection to the issuance of this license as the applicant has been made aware of seating capacity.

#### **Plumbing**

- The Inspector of Plumbing and Gas fitting has no objection to the issuance of this license.
- All plumbing and gas fitting work requires that the permits be obtained from this
