Hayner appointed to this position given his long-standing history with the School Committee as the Arlington 250th Anniversary Committee had requested a School Committee Representative. B. Dr. Homan provided document comparisons and noted that the handbooks have been reviewed by Legal Counsel. Dr. Homan welcomed questions from the Committee.

Dr. Allison-Ampe asked about the elementary handbook homework policy (homework in lower grades). L. Gitelson asked if there is a consistent policy in the elementary schools due to discussions on the Arlington Parent ListServe. Dr. Homan answered the questions accordingly and reported that there is not a consistent across districts. J. Morgan commented about the inconsistency in the reading-log piece. Dr. Homan and Dr. Allison-Ampe commented. Student clothing in the high school was discussed as well. Dr. Allison-Ampe and L. Kardon had questions on the illness policies and Dr. Homan answered accordingly. L. Kardon abstained from the vote regarding the High School Doctor note in the handbook.
