To Residents of Oldham Road:

Due to an error with the Arlington Advocate & Star not publishing the legal notice; the public hearing has been rescheduled for Monday, September 11th at 7:15 p.m. conducted via hybrid format. We sincerely apologize for this inconvenience.

The Arlington Select Board will hold a public hearing on a petition received from two-thirds of the abutters of the private way known as Oldham Road in accordance with Arlington Town bylaws, "Repairs to Private Ways", on **Monday, September 11, 2023, at 7:15 p.m. conducted via hybrid format.** Information regarding this meeting will be available on the Town's website 48 hours prior to the meeting.

The purpose of the public hearing is to determine if the repairs should be made. The public hearing will provide property owners an opportunity to be heard on the matter prior to the Select Board taking action on the petition.

The total estimated cost of the work to be done is \$75,447.00. The estimated assessment, per lot, to the abutting property owners is \$5,803.62. If the Select Board approves the project, one-third of the total estimated cost, \$1,934.54 is required by check or money order prior to the start of the project. The remaining balance will be due upon completion, or if you choose, it can be assessed on your tax bill for payment over a **five year period with interest**, in accordance with M.G.L. Chapter 80, the Betterment Act.
